D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I observed a black 2009 Chevy bearing FL Tag 153WRT going south on S. Central Blvd from University Blvd. I observed the vehicle make several abrupt lane changes prior to entering the roundabout and then exit the roundabout from the inside lane over two solid white lines. The vehicle continued south on S. Central Blvd and approach Donal Ross Rd. The vehicle began going into the farthest right left turn lane to go east bound Donal Ross Rd. Just before the intersection the vehicle made a hard turn to go back into the straight lane and then once again to the left to get into the left turn lane. Based on this driving pattern I conducted a traffic stop to check on the wellfare of the driver.

OBSERVATION OF DRIVER:

I made contact with the driver of the vehicle who was identified as W/M Alexander T. Beel (11/27/1992) by Florida Drivers license. While speaking with Beel I identified myself and explained why I stopped him. Beel was asked if he was having any medical issues which would cause the abnormal driving pattern to which he stated no. I noticed the odor of an unknown alcoholic beverage coming from his person. I also noticed that Beel had glassey eyes.

DRIVER'S STATEMENTS:

Beel stated that he had three beers earlier in the night around 10 pm to which he confirmed that they were pint size beers. Beel stated that on a scale of 1-10 with 1 being completely sober and 10 being the most drunk he had ever been that he was about a 5. I asked Beel if he felt the effects of alcohol to which he stated he did.

ODORS:

Odor of an unknown alcoholic beverage coming from his person.

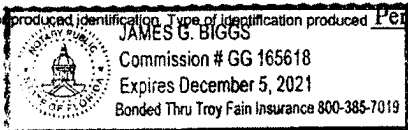

Other Observations:

Failed to keep his head still and keep eyes focused on the stimulus several times.

WALK & TURN:

Beel kept his shoes on and stated he understood the instructions. Beel failed to maintain the starting position after being instructed not to move. Beel missed heel to toe several times. Beel failed to watch his feet and count out loud. Beel utilized his arms for balance. Beel completed the incorrect number of steps and turned around improperly. Beel once again missed heel to toe several times and stepped off line.

ONE LEG STAND:

Beel stated he understood the instructions. Beel lifted his left foot in the air and then placed it down a short time later. Beel lifted his left leg again before placing it on the ground about a second later and picking his foot back up and looked straight ahead prior to the 30 seconds expiring.

FINGER TO NOSE:

Beel stated he understood the instructions. Beel failed to bring his hand immediately back down to his side several times. Beel was also explained to use the tip of his finger and not the pad or the sides to which he utilized the pad of his finger each time.

ROMBERG ALPHABET:

Beel stated he had an AA degree in college and was comfortable with the English Alphabet. Beel correctly recited the alphabet.

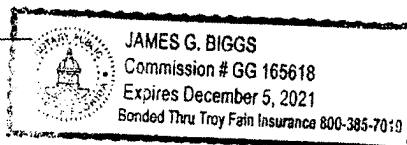
