The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law The Person taken into custody ☒ committed the below acts in my presence ☐ confessed to _____ admitting to the below facts. ☐ was observed by _____ who told _____ ☒ that he/she saw the arrested person commit the below acts ☒ was found to have committed the below acts, resulting from my (described) investigation On the 25TH day of AUGUST 2018 at 9:45 ☐ A M ☒ P M (Specifically include facts constituting cause for arrest) On Saturday, August 25, 2018 at approximately 2145 hours, I had responded as a backup deputy on a traffic stop on southbound State Road 7 just South of Pioneer Rd within the incorporated Village of Royal Palm Beach, in Palm Beach County, Florida 33414. While on scene, I observed an unrelated white four door SUV vehicle drive up over a curb and pop a tire across the street on the East side of S State Rd 7. I then observed a W/M get out of the passenger seat of the SUV and run North along S State Road 7 into the road filled with moving vehicles. The SUV then turned around and parked along the side of the road. Another W/M exited the vehicle and chased after the passenger. Then I observed the driver grab on to the passenger and pull him down to the ground off to the side of the road out of traffic and began what appeared to be physical confrontation between the two. I then ran across the road and detained both subjects with handcuffs. I then spoke to the driver, who was identified as Christian Elder (W/M; 8/24/1991). Christian stated he and his brother, Alexander Elder (W/M; 8/24/1991), were driving from a wake as their uncle had just passed away. Christian stated Alexander was not dealing with the family death well and drank too much alcohol during the wake. Christian continued stating as he was driving the vehicle, Alexander got out and began running from the vehicle into traffic. Christian stated he drove his vehicle off the side of the road and got out to chase Alexander so he did not run into traffic and get hit by another vehicle. Christian stated he had to physically restrain Alexander on the ground to keep him from running into traffic. I then made contact with Alexander. Alexander was uncooperative and stated he only had one alcoholic beverage, but had slurred speech, and would scream at deputies when asked a question. I could also smell the strong odor of an unknown alcoholic beverage coming from Alexander's person. When I asked Alexander what had happened, he responded with, "My uncle died," along with, "I don't have to tell you shit," and, "Fuck you... Christian! They have nothing on you, don't say a fucking thing!" I then made the determination Alexander was causing a public disturbance due to his intoxication and would continue to run out into the road and impede traffic and cause a motor vehicle crash, which would result in injury to himself or others. Due to my investigation, I found probable cause to arrest Alexander Elder for disorderly intoxication as per FSS 856.011(1).
