On the above date & listed time while traveling southbound on Interstate 95 in the area of Palm Beach Lakes Blvd which is located in Palm Beach County, Florida, I observed a vehicle traveling in lane #1 which was quickly approaching my marked PBSO patrol vehicle at a high rate of speed. I visually estimated the vehicle to be traveling well above the posted speed limit of 65mph. I activated my in-car radar unit utilizing the rear antenna for oncoming vehicle, same direction. The radar unit emitted a clear and high pitched Doppler tone indicative of a high speed. The unit gave an actual displayed speed of 105mph. I moved into lane #2, allowing the vehicle to pass safely. Once past my vehicle, I elected to initiate a traffic stop on the black 2016 Kia Optima bearing Florida tag GLT-V23, activating the emergency lights and getting the driver to yield at the Belvedere Road exit. Upon making contact with the driver and sole occupant, a W/F who identified herself as "ALEXANDRA GENEVIEVE KUNZ" by her Florida driver license, I immediately detected a strong and obvious odor which I recognized through my training and experience as marijuana. Additionally, I observed marijuana residue, commonly referred to as "shake" on the front seat, floorboard and center console area. KUNZ was asked to exit the vehicle and when asked, stated the marijuana was in the gold bag. KUNZ was taken into custody without incident. A search of the vehicle revealed a plastic bag with a green leafy substance suspected of being marijuana in a gold purse on the front seat. Another plastic bag with suspected marijuana was located in a gym bag behind the driver seat, belonging to KUNZ. A freshly rolled marijuana cigarette known as a "blunt" was located in the center console along with a metal cylindrical container known as a "grinder". The suspected marijuana was field tested utilizing an issued PBSO test kit which proved positive for THC. The total package weight of the suspected marijuana was approximately 17.1 grams.

Therefore, through my on scene investigation and evidence recovered, I find probable cause for the arrest of "ALEXANDRA GENEVIEVE KUNZ", who was unlawfully and knowingly in actual or constructive possession of less than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b), a 1st degree misdemeanor and who was unlawfully and knowingly in actual or constructive possession of "Grinder, which was drug paraphernalia being used, intended for use, or designed for use in storing, containing or concealing a controlled substance, contrary to Florida Statute 893.147(1)(a), a 1st degree misdemeanor.
