On 1/20/2017 at approximately 1409 hours I was patrolling the Palmetto Park Square shopping plaza (1401 W. Palmetto Park Rd) when I was approached by an anonymous female. She informed me that there appeared to be an unconscious female sitting in a blue vehicle on the south side of K-Mart near the garden center. The vehicle, a blue Chevrolet Malibu (Fl tag ENB-R66), was properly parked facing west in the parking lot. The vehicle was running and the passenger seat was occupied by a white female. She was slumped over toward the driver's seat while holding a cellular telephone in her left hand. A multicolored purse was also resting on the female's lap. I knocked on the passenger side window waking the female up. As she opened the passenger side door, I immediately detected the odor of marijuana emitting from the vehicle. The female was identified by her Florida driver's license as Alexandra Wilburn (12/10/1990). As additional units arrived on scene, I asked Wilburn to exit the vehicle to speak with me. I addressed the odor of marijuana and asked if there were any illegal narcotics in the vehicle. Alexandra replied no but said that there were a number of prescription bottles in the vehicle containing pills that are prescribed to her. While searching the contents of the vehicle, specifically the multicolored purse that had been on Alexandra's lap, I discovered small pink plastic baggie inside a pack of Kool cigarettes. The pink baggie contained a green leafy substance that I suspected to be marijuana. Also in the purse was a green pill bottle containing Clonazepam pills. Mixed in with these pills were two Xanax pills. Alexandra acknowledged being in possession of the pills and admitted that she did not have a prescription for them. Additionally a third Xanax pill was discovered inside a purple gift box with "Hallmark" labels on it. Alexandra admitted ownership of this pill also. No other contraband was found inside the Malibu or on Alexandra's person.

Alexandra was transported to the Boca Raton Police Department to be processed into our facility. Once processing was complete, she was turned over to the Palm Beach County Jail in West Palm Beach. The green leafy substance field tested positive for marijuana using a quick check marijuana field test kit. The marijuana weighted in at 0.4 grams including packaging. The marijuana was packaged and entered into evidence at the Boca Raton Police Department to be held for trial. The three Xanax pills, weighing 0.5 grams, were also packaged and entered into evidence at the Boca Raton Police Department to be held for trial.
