Whitfield and his live-in girlfriend w/f, Alexandria Simpson (06/22/1983) were in a verbal argument about an incident that happened last night. Whitfield advised me that they were arguing about his ex-girlfriend showing up at the night club and causing a scene.

It should be noted that Whitfield appeared upset and had fresh scratches on his neck and face. The injuries were still bleeding. Whitfield could not explain how he got the scratches on his face.

I then made contact with Alexandria Simpson who advised me that she and Whitfield were in a verbal argument because of last night's incident. Simpson then admitted to scratching Whitfield's face because he got too close to her while they were arguing. It should be noted that Simpson has bruises on her face from a fight that happened last night with Whitfield's ex-girlfriend.

Whitfield refused to complete a witness statement or sign a victim's notification form.

(2) Photographs were taken of Whitfield's injuries before he refused to allow for more.

Simpson was placed under arrest, (handcuffs were double locked and checked for tightness).

Based on the facts from above I believe there is probable cause to charge Alexandria Simpson (06/22/1983) with: Domestic Battery- Simple touch / Strike.

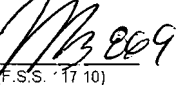
Simpson was transported to the Lantana Police Department for further processing and then was transported to the Palm Beach County Jail.
