On 01/19/2017 at approximately 2145 hours I responded to the area of 11711 Okeechobee Blvd Royal Palm Beach in reference to back up for a traffic stop for Sgt Essary 5428. Upon arrival observed a Crème 2001 Lincoln 4 door FL Tag Y12NJS with a white female driver identified by FL DL as Alexis Andrea Vanden Bosch. When I approached the vehicle Andrea rolled down the right rear window and I could smell the odor of marijuana emanating from the vehicle. I asked Alexia If there was anything in the vehicle I should know about. Alexis told me there was marijuana in the vehicle and produced a partially burnt marijuana cigar. At this point dispatch informed me that Alexis did not have a valid license and there was a seize tag order issued for her vehicle. I then requested Alexis step outside of the vehicle and asked her if there was anything else in the vehicle I should know about and she told me there was Xanax in the car as well and told me it may be in her purse. At this point i informed Alexis she was under arrest, placed her in handcuffs which I checked for proper fit and double locked. Alexis was then placed in the rear of my marked PBSO patrol vehicle. While searching the vehicle for any other contraband I located a green leafy substance! suspected to be marijuana wrapped in a plastic bag and a white piece of paper (2.7 grams), two oval blue pills with one score mark in the center and "GG 258" marking, two small white colored square suspected crack rocks (.3grams) located in a silver metal container. I field tested the suspected marijuana using a Duquenois Reagent: Marijuana-Hashish-THC test which produced a positive purple color indicating the presence of THC. I then field tested the suspected crack cocaine with a Cobait Thiocyanate Reagent: Cocaine-Crack test which produced a positive blue color indicating cocaine. I then confirmed with Poison Control worker Kiet that the two blue pills recovered are 1 mg alprazolam. Post Miranda Alexis stated that the crack was a friend of a friend who left it in the vehicle a day ago. Based on my investigation | believe Alexis Andrea Vanden Bosch was unlawfully and knowingly in actual or constructive possession of (2.7 grams) less than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marljuana, a controlled substance, contrary to Florida Statute 893.13(6)(b). (1 DEG MISD), Andrea was unlawfully and knowingly in actual or constructive possession of grams of Alprazolam, a substance classified within Schedule IV Florida Statute 893.03 4a, commonly known as Xanax, a controlled substance, contrary to Florida Statute 893,13(6)(a). (3 DEG FEL) (LEVEL 1) Andrea was unlawfully and knowingly in actual or constructive possession of .3 grams of Crack Cocaine, a substance classified within Schedule II Florida Statute 893.03 2A4, commonly known as Crack, a controlled substance, contrary to Florida Statute 893.13(6)(a). (3 DEG FEL) (LEVEL 1). Based on my investigation I believe probable cause exists for the arrest of Alexis Andrea Vanden Bosch.
