I told Benitez that I needed (2) full ones, street terminology for wanting to purchase (2) ounces of cocaine. Benitez told me to call him tomorrow when I was ready. Benitez reconfirmed that I needed (2) ounces before hanging up the phone. Today 03-08-2018, Benitez attempted to call me twice; however I did not answer the phone at the time. I then called Benitez back on a recorded phone call. I discussed with Benitez to meet after 11AM today to purchase the (2) ounces of cocaine from him. A briefing was conducted at a prearranged location prior to the deal today. Present at the briefing were Agents T. Ward, T Kabis, J. Bango, and DEA (Drug Enforcement Agency) personnel. I drove a Palm Beach county Sheriff's office unmarked vehicle to 4th Street and N. G Street and parked next to the intersection, just south of 401 N. G Street. Prior to my arrival at the location, I noticed that Benitez white Honda was already parked on 4th Street. Benitez drove up behind my unmarked vehicle, exited the driver side front door, walked over to my unmarked vehicle and got into the front seat of my unmarked vehicle. Greetings were exchange and I handed Benitez \$2000.00 in US currency that was previously provided by DEA. The serial numbers were previously recorded by DEA Special agents. Once Benitez took the \$2000.00 he told me that he would be right back. Benitez exits my unmarked vehicle and walked towards the back of the business of Tony Auto Body Shop, located 410 N. G Street, Lake Worth Florida. Agents observed Benitez enter into the rear of the business of Tony Auto Body shop. Moments later, Benitez called me and asked to move over one street north and he will meet with me once he gets the stuff. Benitez said "his guy" didn't like where I parked. I drove one street over to the north over to 5th Street driving towards my unmarked vehicle. Benitez parked his vehicle behind my unmarked vehicle, exitis his vehicle and gets
