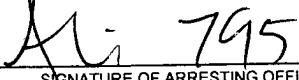
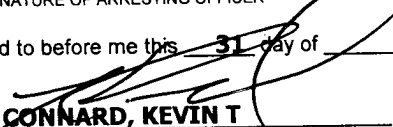

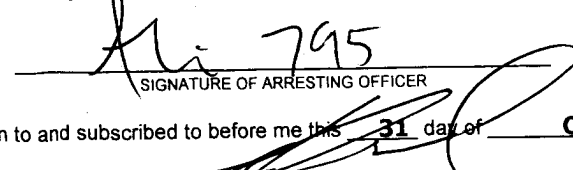

	had an argument. Catoggio stated [REDACTED] was no longer at the apartment. Catoggio explained [REDACTED] and her have been in a long on and off [REDACTED] and advised they were [REDACTED] but are currently [REDACTED] again. Catoggio advised she has a [REDACTED] and stated [REDACTED] was previously the [REDACTED] but is not anymore. According to Catoggio, she and [REDACTED] began to argue about [REDACTED] and specifically about [REDACTED] taking money from her. I asked Catoggio to explain what happened during the argument. Catoggio began explaining the argument, but paused several times, at one point saying "if I tell you I might incriminate myself." Catoggio continued to explain the argument and stated [REDACTED] confronted her about [REDACTED] saying "this is a war you will lose." Catoggio advised she became furious and "saw red" and lunged toward [REDACTED] before being pulled back by her friend Nicole. Catoggio claimed [REDACTED] spat food in her face as she lunged toward him. Catoggio advised she was going to leave the apartment and stated she went outside to move her car, but claimed [REDACTED] followed her and stood behind the car. Catoggio stated [REDACTED] then pretended he was hit by her car as she moved it. Catoggio claimed nothing else physical occurred and stated she drove her car to the other side of the apartment complex and asked a neighbor to call police. Catoggio stated [REDACTED] probably left the area. I asked Catoggio if she would let us check the inside of the apartment to verify [REDACTED] was no longer on scene. Catoggio initially stated she did not want us to go inside and advised her apartment was a mess, but eventually stated we could go inside and look for [REDACTED]. Ofc. Pratt and I entered the apartment and found [REDACTED] laying facedown asleep on the bed in the master bedroom. I woke [REDACTED] up and asked him what happened. [REDACTED] stated he'd show me a video but wasn't sure if he wanted Catoggio to get in trouble. [REDACTED] then explained he woke up and was eating breakfast in the bedroom when Catoggio began arguing with him. According to [REDACTED], Catoggio grabbed a kitchen knife and held it to his throat before being pulled away by Nicole. [REDACTED] described the knife as being large, approximately 12 inches long, and kept in a sheath. I was unable to locate a knife matching that description. [REDACTED] stated he attempted to walk away when Catoggio lunged at him and bit his back. It should be noted I observed a reddened swollen bite mark on [REDACTED]'s upper right back, as well as a scratch on his arm and several other red marks. Catoggio then got off of [REDACTED] and walked outside. [REDACTED] stated he followed her to try and speak with her as she sat in the driver seat of her car. [REDACTED] advised Catoggio opened the driver door and began speaking with him before attempting to reverse, hitting [REDACTED] with the open door. [REDACTED] advised this incident was caught on his cell phone camera. [REDACTED] showed me the video. The angle of the camera, which was held by [REDACTED], shows he was standing close to the car while Catoggio sat inside with the driver door open. Catoggio can be heard screaming at [REDACTED], at which point the camera shakes and the car appears to move. Immediately after, [REDACTED] is heard saying "she just hit me with the car." While looking at the video I was unable to determine if the vehicle actually moved and actually hit [REDACTED]. [REDACTED]' claim in the video sounds exaggerated. [REDACTED] was also standing on the side of the car, which lead me to believe he was not struck intentionally. [REDACTED] advised he was medically ok and stated he did not need medical treatment. Ofc. Pratt photographed [REDACTED]' injuries and submitted them to BRPD evidence. After speaking to [REDACTED], I asked Catoggio about the bite mark. Catoggio began to shake her head up and down and stated she was so angry at [REDACTED] and again stated she "saw red." While speaking to me Catoggio physically made a lunging motion when stating how angry she was. I asked Catoggio about the knife, but she claimed she never grabbed a knife and advised the incident occurred in the bedroom and not the kitchen. When asked about the incident with her car, Catoggio stated she did not intentionally hit [REDACTED] with the car and advised she was just trying to back out of the space. Based on the information obtained during my investigation, the statements made by both parties involved, and

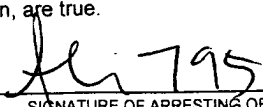
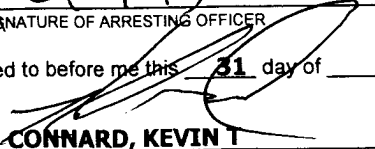
