On 06/20/17, at approximately 2206 hours, I arrested Alisia Kenbok (W/F, DOB 10/30/37) for driving under the influence, pursuant to Florida State Statue 316.193 (1), Resisting/Obstructing Officer Without Violence, pursuant to Florida State Statue 843.02 and Fleeing or Attempting to Elude, pursuant to Florida State Statue 316.1935. The facts are as follows: I was dispatched to Taboo restaurant on the 200 block of Worth Ave for an intoxicated driver. The driver was the subject of a reported intoxicated person at Taboo restaurant. It was reported that she was attempting to get into the Mercedes 4D bearing FL Tag# AYGI34 while noticeably intoxicated. Communications came over radio and advised me the description of the vehicle was an older model Mercedes with a left taillight out bearing a FL tag AYGI34. I surveyed the area and I observed the vehicle traveling eastbound in the 200 block of Peruvian Ave, then made a right turn heading southbound on S. County Rd. The vehicle was traveling slower than the posted speed limit. The vehicle was then seen making a right turn onto S. Ocean Blvd refusing to stop when lights and sirens were activated. The vehicle then processed to travel westbound on Southern Blvd into West Palm Beach, with lights and sirens activated the vehicle did not stop. The vehicle continued to enter I-95 northbound, the vehicle was swerving in and out of the traffic lanes, speeding up and slowing down the entire way to Exit 77, Northlake Blvd where Palm Beach Police had the vehicle blocked in on the off ramp. As Sgt. Alber and myself rushed in, to turn the vehicle off the driver was not complying with police commands. When attempting to have the driver exit the vehicle the driver resisted and refused to obey my lawful commands. The driver was later identified via FL/ DL W/F Alisia Kenbok DOB 10/30/37.
