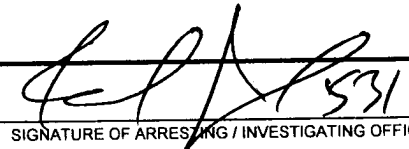

On 11/17/2016 at 0024 hours, police dispatch received a call from an anonymous complainant. The subject advised there was a female in a Nissan with NC tag DMR-6200 in the parking lot of 1400 West Glades Road, Boca Raton, Florida. The vehicle had a flat tire and the driver was impaired. I heard the call being dispatched over the police radio. Myself and Officer Alzamendi arrived at 0027 hours. When we arrived, I observed the Nissan in a parking space in front of Mario's restaurant. The vehicle had it's head lights on. The left front tire was flat and there was damage to the rim like it had been driven on. As I pulled close to the vehicle, subject later identified as Alison Bernstein exited from the driver's seat with the vehicle keys in her right hand. There were no other occupants. I asked Bernstein if she was okay. She stated she was trying to get home. I asked her how she obtained a flat tire. She did not know that she had a flat tire. She stated she had 1 drink earlier with a friend. While I was talking with her, I could smell an odor of a alcoholic beverage coming from her breath. Her eyes were red and glassy. Her speech was slurred. Her face was flush. She was swaying while standing. I set up my in car camera and asked her to walk to the front of my vehicle. She was swaying while walking. I explained my observations and asked her if she would attempt the road side tasks. She stated she would. She has no injuries and takes Prozac. The first task was the horizontal gaze nystagmus. There was a lack of smooth pursuit in each eye. Distinct and sustained nystagmus at maximum deviation in each eye. Onset of nystagmus prior to 45 degrees in each eye.

The second task was the walk and turn. She was allowed to remove her shoes. She left the starting position. She did not touch heel to toe on each step. She raised her arms. She was not counting out loud. She was stepping off the line. She walked more then 9 steps out.

The third task was the one leg stand. She raised her right leg. She was not counting out loud. She bent her knee back. She was not looking at her raised foot. She raised her arms. She was swaying. She dropped her foot to the ground and then stopped.

The fourth task was the finger to nose (L-R-L-R-R-L). She was swaying front to back. She was leaning on the vehicle. She missed the tip of her nose on each movement. On the 1st she held her hand up for an extended period of time.

The fifth task was the romberg/alphabet. She was swaying front to back. She sang through the letters.

At 0053 hours, she was placed under arrest. The vehicle was removed by Westway Towing. We transported Bernstein to The BRPD.

Officer Crawford conducted The Intoxilyzer 8000 testing. I asked her to provide a breath sample. She asked does it matter? I read her Implied Consent. I answered her questions. I asked her again to provide a breath sample and she stated no. She was issued a refusal at 0137 hours.

She was charged with DUI FSS 316.193(1). She was given the court date of 12/12/2016 at 8:30am. The video was submitted into property. After processing she was transported to The PBCJ.
