On 09/06/2016 at approximately 01:29hrs while conducting traffic enforcement in the area of South Haverhill Road and Summit Blvd located in unincorporated West Palm Beach, Palm Beach County I observed a black Ford Explorer Sport-Trac bearing Florida tag BXT-X72 traveling south on Haverhill Road in lane #1. While approaching Summit Blvd the Ford effected a left hand turn from lane #1 which is a straight lane. I elected to initiate a traffic stop on the Ford for failing to use designated lane. I activated the emergency lights on my marked PBSO patrol vehicle with the ford yielding in the 4800 block of summit Blvd. Upon approach of the vehicle, the driver lowered both of the front windows allowing a dense plume of smoke to emit from the interior. This smoke was immediately recognized through my training and experience as suspected marijuana. I alerted the driver and front passenger, a W/F who was identified by her Florida driver license as "ALISSA GERADO" to my detections. The passenger, Gerardo immediately stated that she had the marijuana in her purse. Investigator S. Levey #9415 retrieved the purse from Gerado and removed a plastic bag which contained green leafy substance suspected of being marijuana from the side pocket of her navy blue purse. Additionally, a package of "Job 1 1/4" rolling papers and a multibrown colored glass pipe from the interior compartment was recovered. Gerardo further admitted to smoking a joint with the driver just prior to getting pulled over. The recovered suspected marijuana was field tested utilizing an issued PBSO Duquenois-Levine Reagent field test kit which proved positive for THC. The total package weight of the recovered suspected marijuana was 8.0 grams. Gerado was taken into custody without incident.

Therefore, through my on scene investigation, the statements by Gerado, and the evidence recovered, I find probable cause for the arrest of "ALISSA GERADO" who was unlawfully and knowingly in actual or constructive possession of less than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b), a 1st degree misdemeanor and was unlawfully and knowingly in actual or constructive possession of rolling papers, a glass pipe with residue, and a plastic bag which contained the suspected marijuana, which were all drug paraphernalia being used, intended for use, or designed for use in injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance, contrary to Florida Statute 893.147(1), a 1st degree misdemeanor.
