On 02/13/2018 your Affiant was conducting surveillance in the area of Okeechobee Blvd and Palm Beach Lakes Blvd in reference to the overwhelming amount of narcotics transactions that have been occurring in the area. Your Affiant observed a Blue 2009 Volkswagen Jetta bearing FL Tag IQZU71 leaving from a known drug area as it begin to travel west bound on Okeechobee Blvd from Palm Beach Lakes Blvd. Your Affiant began to follow the vehicle which was being driven by an unknown white female. As the Vehicle was traveling west bound on Okeechobee Blvd, your Affiant observed an aggressive driving pattern. The vehicle on several occasions began to abruptly change lanes without signaling (cutting off other drivers) and also was tailgating other vehicles. Your Affiant requested the assistance for Agents Santiago and Birch to affect a traffic stop on the Blue 2009 Volkswagen Jetta bearing FL Tag IQZU71. Once Agents Santiago and Birch were in the area, your Affiant allowed them to continue to follow the vehicle so more probable cause could be established. It should be noted that your Affiant is driving an un-marked vehicle that does not have Police Lights or a Siren requiring your Affiant to request assistance to stop the Blue 2009 Volkswagen Jetta bearing FL Tag IQZU71. Agents Santiago and Birch after finding more probable cause to stop the vehicle, conducted a traffic stop on the 5500-Blk of Okeechobee Blvd. Upon Agents making contact with the driver later identified as Alissa K. Ross they learned that she had no valid driver's license. During the encounter Agents Santiago and Birch obtained permission to search Ross' vehicle and located in her purse/wallet was 6 caps containing a brown powder suspected to be Heroin. The suspected Heroin tested positive (MARK II) and weighed 1.5 grams. The Heroin was placed into WPB evidence. Based on the above stated facts there is probable cause to arrest Alissa K. Ross for FSS 893.13-6a Possession of Heroin and FSS 322.03(1) Driving W/O FL DL
