Officer Loconsole arrived on scene and stood by with Vecchio while Officer Heinicka and I met with Raymond in apartment #401. Raymond's eyes were red and she was shaking and cried while she spoke. I asked Raymond to tell me what happened. Raymond told me that she and Vecchio were boyfriend and girlfriend and lived together. Raymond stated that after being gone most of the night Vecchio began banging on the door and yelling to be left in. Raymond said she was scared so she called 911. Raymond said she opened the door thinking the police were there and when she didn't see officers she shut the door. Raymond stated she heard Vecchio yell that she had slammed the door on his head but didn't think she did. Raymond said she opened the door again and Vecchio rushed in, "caping". Raymond stated she pushed Vecchio in the chest to try to push him out and grabbed him, ripping his shirt off. Raymond pointed to a gray tee shirt lying on the floor next to the west facing sliding door. Raymond explained that she belfeved Vecchio would have scratches on his because her nails are long. Raymond said Vecchio fran into the south bedroom, ripped the television off the wall, grabbed his Xbox and left through the front door. I asked Raymond why she pushed and grabbed Vecchio. Raymond stated she had PTSD from a previous abusive relationship, was scared and wanted to show Vecchio that this was her safe space. Investigations revealed that Alexandra P. Raymond committed simple battery, domestic related, on Stephen J. Vecchio by pushing, grabbing and scratching Vecchio, contrary to F.S.S. #784.03, after he entered the apartment they share as a couple. I informed Raymond that she was under arrest and Officer Heinicka placed her in handcuffs which were checked for tightness and double-locked. Raymond was transported to the Boca Raton Police department for processing and turned over to the Palm Beach County Jail.
