PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was dispatched to the area of SW 18th street west of Boca Rio Road in unincorporated Boca Raton in regards to a person that was operating a white range rover bearing fl tag # RIR710 west bound on SW 18th street and had driven over a sidewalk and had a flat left front tire. The caller was Captain Larry Ervin, ID # 130, with the FAU police department, a fellow law enforcement officer. Upon my arrival, Captain Ervin was stopped in his personal vehicle with his emergency flashers activated, several car lengths behind the now stopped Range Rover. Captain Ervin directed me to the vehicle, where I came to find the defendant in the drivers seat with her seat belt on, her head slumped over, apparently asleep. The vehicles transmission dial was still in Drive and the car was still running. I noticed that the left front tire and was damaged, where as the rubber part of the tire was mostly missing and the vehicle had been driving on the rim for some distance as the rim too was damaged.

OBSERVATION OF DRIVER:

Upon being able to wake the defendant by shaking her and audibly trying to wake her, her speech was slurred and she was incoherent. Her eyes were red and glossy. The defendant believed that she was in Palm Beach Gardens near her home. I asked the defendant if she had any medical issues, which she said that she did not. I further asked if she took any medication and she said that she did not. The defendant was asked for her identification and she had trouble locating it within her wallet and once located tried to hand me her entire wallet, I asked her to remove her license and she was able to get it out of her wallet after a short time. While the defendant was rummaging through her purse, I observed in plain view two small bottles of Sutter Home White Zinfandel, one of which was partially consumed. Palm Beach county fire rescue # 56 responded to the scene on run # 17-083614 and confirmed that the defendant was not having a diabetic incident or any type of life threatening medical emergency. When asked to exit the vehicle, the defendant stepped out and almost fell face first into the ground and had to be caught by D/S Grant and I.

DRIVER'S STATEMENTS:

Driver said that she had been driving to an interview and believed that she was in Palm Beach Gardens near her home.

ODORS:

Odor of unknown alcoholic beverage coming from the breath of the defendant.

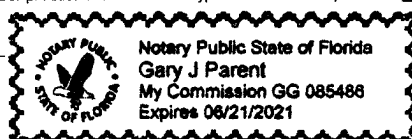

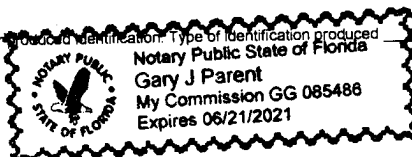
