Vehicle was entering the town of Palm Beach at the Royal Park Bridge (515 Royal Palm Way) and was stopped at a vehicle and pedestrian checkpoint by PBPD. The vehicle was driving into town after curfew hours (Midnight) and restricted vehicles access due to the aftermath of Hurricane Irma. The driver and lone occupant, smelled of alcohol, had blood shot eyes, throw up on the driver's side door, and a open Corona bottle in the front cup holder. 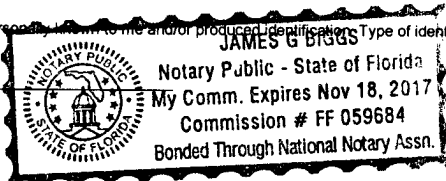

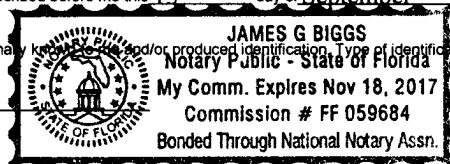
