On July 27th, 2017 at approximately 1717 hrs, I (D/S Estavien ID 27531) along with Sgt. Kennedy (ID 7248) and D/S Vickers (ID 6316) were on routine patrol in an unmarked vehicle in the area of Lake Worth Rd & State Rd 7.

While in the area we were advised via dispatch that a vehicle had just been reported as stolen, and that they were in contact with On Star who was tracking the vehicle. On Star informed PBSO Dispatch that the vehicle was stationary at 133 S STATE ROAD 7, Wellington, FL 33414. The vehicle was described as a Yellow Chevy Camaro bearing FL TAG GIFX65. On Star then advised PBSO Dispatch that the vehicle had begun moving, traveling south bound on State Road 7 from the above location. At that point we moved into position to gain visual contact with the vehicle. We gained visual contact of the stolen Chevy Camaro in the 4100 Block of State Road 7. We observed that the vehicle was occupied by three (3) individuals, later identified as Braxton Francis (Driver - B/M adult, D.O.B. 8/19/1995), Alyssa Arnau (Front Passenger - W/F adult. D.O.B. 6/10/1999), and Tristan Anoza (Rear Passenger - B/M adult, D.O.B. 10/29/1996). We then activated our emergency lights & sirens in the 4200 block of State Road 7 in an attempt to conduct a felony stop on the stolen vehicle. After activating our lights & siren, I observed the rear passenger (Tristan) look back at us several times rapidly as if in panic. The vehicle then abruptly changed lanes and sped off, fleeing south bound on State Road 7 towards Hypoluxo Road. At that point we deactivated our emergency lights & sirens and did not pursue the stolen vehicle. PBSO Dispatch then advised us that since the vehicle was equipped with the On Star system, On Star had the capability of slowing the vehicle down to a safe stop. Dispatch further advised that On Star was ready to activate that capability, and they wanted to know when we would like them to do so.

We maintained visual contact with the stolen vehicle after it fled from us, and advised On Start to activate the capability to slow the vehicle down. After the On Star activation, the vehicle began slowing down as it continued fleeing south on State Road 7. We observed the vehicle continue fleeing south on State Road 7, then east on to Hypoluxo road. The vehicle then came to a stop in the 9600 block of Hypoluxo Road. After the vehicle came to a stop, I observed Braxton, Tristan, and Alyssa exit the vehicle and flee on foot. They fled towards a wall in the 9600 block of Hypoluxo Road and attempted to climb it.

They were unable to climb it, and we were able to stop them. I took Alyssa into custody and placed her under arrest. I placed her in handcuffs behind her back, and check them for proper fit and placement. Search incident to arrest I discovered a small plastic bag containing brownish / green plantlike material; suspected marijuana, in Alyssa's handbag. The suspected marijuana was field tested using Nark 2 Duquenois-Levine Reagent Marijuana Test kit, and the results were positive indicating the presence of THC.

Alyssa was read her Miranda rights, and she acknowledged that she understood them. I spoke to Alyssa and she stated that she ran because she was scared and did not know what was going on. She further stated that she got the weed from family members who came from California.

Based on the aforementioned events, Alyssa was placed under arrest for Resisting arrest without Violence pursuant to F.S.S. 843.02, and Possession of Marijuana less 20 grams pursuant to F.S.S. 893.13 (6B). She was transported to PBSO District 8 for processing, then later transported to Palm Beach County Jail. The marijuana seized was submitted to District 8 evidence.
