The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law: ☒ committed the below acts in my presence. ☒ was observed by <u>OFC. CASTANEDA</u> who told <u>OFC. CASTANEDA</u> that he/she saw the arrested person commit the below acts. ☐ confessed to _____ admitting to the below facts. ☒ was found to have committed the below acts, resulting from my (described) investigation. On the <u>10</u> day of <u>October</u>, <u>2019</u> at <u>19:06</u> (Specifically include facts constituting cause for arrest.) On 10/10/19 at approximately 1418 hours, I was flagged down by a white female who at the time was driving a silver Cadillac sedan. At time of contact I was parked at the south parking lot of the Jupiter Police Department. I asked the female driver who was later identified through N/FCIC as Alyssa Rivera (W/F, DOB: 5/17/94) if I could help her with anything. Rivera then stated "Someone stole my shit". I asked Rivera to be more specific and to provide the time of the incident. Rivera stated "Someone broke into my house, and stole my IDs, and my conceal permit". I asked Rivera if she entered her residence and she did not answered my question. I also asked Rivera if she contacted the Police and she said "It was documented". Rivera appeared to be agitated because she was moving inside her vehicle. Rivera also spontaneously uttered "I have a gun, and I'm a cop". I then exited my patrol vehicle (#1808) and attempted to make contact with Rivera. I advised Rivera to remain in her vehicle but Rivera Rolled up her vehicle's front passenger side window and drove off. Rivera drove north bound on the east side parking lot in front of the Jupiter Police Department's east lobby, then made a right turn to go south bound on Military Trail. I proceeded to follow Rivera in my patrol vehicle to attempt a welfare traffic stop because Rivera statements were not making sense, and to ensure she was not impaired to drive. I then turned on my patrol vehicle's emergency lights and siren and conducted a traffic stop south bound on Military Trail in front of the Jupiter Police Department (210 Military Trail) on a silver Cadillac bearing FL tag 745QPQ. The final point for my traffic stop was south bound on Military Trail at the intersection of Toney Penna Dr. I made contact with Rivera who was the driver and sole occupant of the Cadillac sedan. I introduced my self as a Jupiter Police Officer and explained Rivera the reason for my traffic stop. As I made contact with Rivera I observed a black case (gun case) with the black lettering GLOCK resting on the front passenger seat. Rivera was extremely

uncooperative at the time and was speaking over me. Rivera stated "You're not pulling me over, you're not pulling me over". I advised Rivera my contact with her was a legal traffic stop, and she needed to comply with my lawful orders. Rivera rapidly rolled up her/driver's side window and sped off failing to yield to a traffic red traffic signal at the intersection of Military Trail and Toney Penna. Rivera continued to driver south bound on Military Trail. As Rivera sped off in her vehicle I drew my Jupiter Police Department issued handgun and ordered Rivera to stop her vehicle. Rivera continued to drive off fleeing the scene of the traffic stop, and eluding me (police officer). I then advised dispatch the driver of the vehicle left the scene of my traffic stop. I followed Rivera in my patrol vehicle south bound on Military Trail. At the intersection of Military Trail and Oak Terrace Riviera maneuvered her vehicle from the outer lane (right lane) to the middle lane in an aggressive manner causing a silver sedan that was driving south bound on Military Trail to break forcefully. Rivera then turned east (left) from the middle lane at the intersection of Military Trail and Summer Winds Lane in one single movement. I continued to follow Rivera and attempted another traffic stop at the 300 block of Summer Winds Lane. Rivera then stopped her vehicle near the 500 block of Summer Winds Lane. I then exited my patrol vehicle and conducted a high risk felony traffic stop. I gave Rivera commands to take her hands out of her vehicle. Rivera ignored my commands. I continued to order Rivera to comply with my commands which she continued to ignore. At one point Rivera stated she was not going comply with my lawful orders. Momentarily after, Rivera was speaking to someone over the phone. I could hear Rivera speaking to someone over the speaker phone. Several other officers arrived on scene including female Officer Ercolano #344. Officer Ercolano attempted to communicate with Rivera but Rivera ignored Officer Ercolano. North Communications Center advised Rivera contacted dispatch. Dispatch then advised Rivera stated she had a gun with her but the gun was put away. Momentarily after, dispatch advised Rivera changed her statement and she was in possession of the gun. Rivera refused to exit her vehicle and refused to comply with officers' commands to exit her vehicle. Rivera then became barricaded inside her vehicle and possibly armed with a gun. Rivera then drove off a second time fleeing the scene of a traffic stop and headed toward the end of the street. Rivera then parked her vehicle in front of 1403 Summer Winds Lane which is her current address. Rivera then exited her vehicle and ran toward her residence's front porch where she grabbed her pet dog. At this point Rivera continued to disregard Officer Ercolano's commands. Officer Ercolano then deployed her taser striking Rivera on the back. Rivera was then placed in custody (handcuffed, double

locked, and checked for spacing). Rivera was treated at the scene by Palm Beach Fire Rescue (run # 19107761). Rivera was also transported to the Jupiter Medical Center to be medically cleared at a later time. At approximately 1300 hours, and prior to me making contact with Rivera, I observed a silver vehicle in the south parking lot area of the Jupiter Police Department that matched with Rivera's vehicle. This vehicle (possibly Rivera's) was driving around at a slow pace in the parking lot and made a series of turns and stops. Based on investigation, Rivera's statements, and Rivera's actions, I developed probable cause to charge and arrest Alyssa Rivera (W/F, DOB: 5/17/94) for fleeing and eluding, and resisting arrest without violence because Rivera did operate a vehicle, having knowledge that he/she had been ordered to stop such vehicle by a duly authorized law enforcement officer, did willfully refuse or fail to stop the vehicle in compliance with such order, or having stopped in knowing compliance with such order, did willfully flee in an attempt to elude the officer, contrary to Florida Statute 316.1935(1) and during the commission, Rivera did unlawfully resist, obstruct or oppose *(Officer Jonathan Castaneda #359), a law enforcement officer of the *(Jupiter Police Department), in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.
