While patrolling the area of Martin Luther King Blvd (NE 10TH AVE) which is a high crime and a high drug area, In my fully marked BBPD vehicle #4449, I observed w/f later identified Alyssa Lloyd speaking to a liver information). Upon Lloyd noticing my presence, she quickly began to walk across the street and away from the area. Shortly after, I made consensual encounter with Lloyd by asking her if she had a minute to speak. Lloyd agreed to talk to me. I asked Lloyd if everything was okay, which she stated that she was on lunch break and had just arrived to the area. I asked Lloyd if she lived in the area, which she replied that she didn't. Lloyd further added that she works all the way in Delray Beach. Lloyd was very nervous and her hands were shaking as she was speaking to me. Lloyd began to spontaneously utter "Please don't take me to jail." I asked Lloyd why would I take her to jail, At which time, Lloyd uttered to me that she is a drug addict and had just bought \$20.00 USD worth of Cocaine. Lloyd further added that the cocaine was in her rear left pocket of her jeans. Lloyd produced two small white wafer like pieces that through my training and experience appeared to be suspect cocaine. Lloyd produced along with the wafer pieces a small piece of copper wire (chore bore), from her rear pocket. Through my training and experience, Chore Bore is commonly used as a filter to smoke crack cocaine. At this time, I placed Lloyd in handcuffs, checked for tightness, and double locked them.  I conducted a field test of the suspect narcotics utilizing a NIK Cocaine Wipe. The wipe turned blue confirming the wafer pieces were crack cocaine.  Based on the totality of the above listed facts, I find probable cause to charge defendant Alyssa Lloyd with possession of crack cocaine pursuant to FSS 893.13.6A  Lloyd was transported to BBPD for processing and later TOT PBCJ. Nothing further.
