I, Officer Dominguez and Officer Acosta, were conducting burglary suppression in the area of Golfview Harbor in reference to the recent and numerous burglaries in the area. While traveling in a department unmarked vehicle I witnessed several people inside a gold Toyota Tundra (FL Tag IQXP37) parked in the driveway of 2560 SW 10th Street. The two subjects, white female and black male, appeared to be rifling through the vehicle. Myself and Officer Acosta parked our vehicle across the street and observed the subjects in the vehicle. After several minutes of observing the subjects moving around in the vehicle myself and Officer Acosta walked over to the vehicle to make a consensual encounter with the subjects.

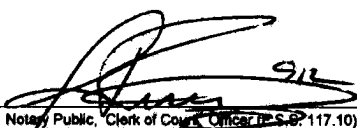
As I approached the vehicle I immediately could smell the odor of Marijuana emitting from the vehicle. I then observed a white female, later identified as Amanda Mostow, quickly exit the driver seat of the vehicle and walk towards Officer Acosta. I continued to walk to the passenger side of the vehicle as the passenger door opened. At that time I made contact with Cameron Miller who was sitting the front passenger seat. While speaking to Miller I observed, in plain view, a clear plastic bag in the cup holder near the radio. In the bag I observed four small baggies of a brown powdery substance, known to me through my training and experience as Heroin. I also observed two small white pill inside the bag. At that time I placed Cameron into handcuffs and Officer Acosta placed Mostow into handcuffs so that we could continue are investigation. While searching Cameron's person I located a brunt glass crack pipe in his right pants pocket.

After conducting a search of the vehicle I located in the front passenger seat floor board a black glasses case with three used needles, spoon and a small baggies with powdery residue inside. I also checked the bag with the Heroin and pills. I used a Pill Identifier which showed the two pills to be Hydromorphone Hydrochloride 2 mg.

I later read Mostow her Miranda Rights from my department issued Miranda Card. Mostow advised she understood her rights and was willing to speak to me. Mostow advised the vehicle was her boyfriends but she recently has been using the vehicle. Mostow also stated that other people were using her vehicle and there may be drugs in the vehicle that she did not know about. Mostow later advised that the Heroin and pills I located in the vehicle was hers and have been in the vehicle for a few days which she forgot to throw away.

I then read Miller his Miranda Rights from my department issued Miranda Card. Miller advised he understood his rights and was willing to speak to me. Miller advised the crack pipe I located in his pocket was his. Miller also stated that when I approached the vehicle Mostow took out the bag with the pills and Heroin and placed it in the cup holder. Miller advised the drugs located in the

vehicle was not his.

Based on the above facts, Miller was arrested for Possession of Paraphernalia pursuant to Florida State Statute 893.147(1). Miller was issued a Notice to Appear in which signed and stated he understood his court date and time. Miller was then released from the scene.

Based on the above facts, Mostow was arrested for Possession of Heroin pursuant to Florida State Statute 893.13(6)(a), Possession of a Controlled Substance pursuant to Florida State Statute 893.13(6)(a) and Possession of Paraphernalia Pursuant to Florida State Statute 893.147(1). Mostow was then transported to BBPD for processing and later turn over to PBSO Jail.

It should be noted that based upon my training and experience I believe the brown powdery substance to be Heroin or a synthetic opioid (net weight 0.2 grams), and too dangerous to field test based upon my understanding of the dangers associated with coming into contact with Fentanyl or similar substances. The suspected Heroin, which was not field tested will be submitted to PBSO Lab per protocol for pre-filing testing.

The drugs and paraphernalia were later placed into evidence. This incident was captured on my BWC.
