PROBABLE CAUSE

DUI ALCOHOL OR DRUGS

On June 11, 2017 I was on routine patrol in my marked patrol vehicle in Palm Beach County. I was dispatched to the area of a possible reckless driver. There were multiple calls into the Florida Highway Patrol communications center in reference to a silver or grey colored BMW with a Florida tag of HNFY84. Callers and witnesses stated that the vehicle was swerving all over the road and was unable to maintain a single lane. I was able to intercept the vehicle and positon my patrol car behind the vehicle on I-95 State Road 9) northbound at 10th Ave N. I observed a grey BMW with a Florida Tag of HNFY84. I observed the vehicle and saw that the vehicle was unable to maintain a single lane and repeatedly straddled between the center left, center and center right lanes. I continued to observe the vehicle from northbound I-95 at 10th Ave N to Southern Blvd. I then activated my emergency equipment and initiated a traffic stop on the vehicle. The vehicle pulled over to the right paved shoulder of the roadway. I approached the passenger side of the vehicle and introduced myself. I then requested that the driver present a drivers license, vehicle registration and proof of insurance. While talking to the driver of the vehicle I observed the odor of an unknown alcoholic beverage emitting from within the vehicle. I observed that the driver seemed disoriented and presented some difficulty in looking for her driver's license. The driver was later identified as Amanda Fanelli by her Florida DL. Ms. Fanelli stated to me that she was going home. I then requested that Ms. Fanelli step out of the vehicle and walk back towards my patrol vehicle. She then stepped out of the vehicle and used the car for balance when she exited. As Ms. Fanelli stood in front of me I observed that she had an orbital sway and bloodshot eyes. I also observed the odor of an unknown alcoholic beverage emitting from her breath. I requested that Ms. Fanelli conduct roadside exercises and she verbally and physically indicated that she would.

Horizontal Gaze Nystagmus

Before beginning the exercises, I checked to see if Ms. Fanelli was wearing glasses or contact lenses. It was determined that Ms. Fanelli was not wearing glasses or contacts. I then checked her eyes and observed equal tracking and equal pupil size. She was instructed to place her feet together and place her nands down at her side. She then was instructed to keep her head still and follow the stimulus with her eyes and her eyes only. She was also instructed to keep looking at the stimulus until told not to. She verbally indicated that she understood. During the exercise I observed 6 of the 6 possible clues.

Lack of smooth pursuit, left eye

Lack of sooth pursuit, right eye

A distinct and sustained nystagmus at maximum deviation in the left eye

A distinct and sustained nystagmus at maximum deviation in the right eye

An onset of nystagmus prior to 45 degrees in the left eye An onset of nystagmus prior to 45 degrees in the right eye

During the exercise Ms. Fanelli had to be told to stay in the proper position and not to move her head during the exercise. I also observed Ms. Fanelli to have orbital swav.

Walk and Turn Exercise

Ms. Fanelli indicated that she had no medical issues that would prevent her from participating in the exercise. She indicated that she had hip problems. I placed a colored line on the ground and observed that there was no debris and the ground was level. Ms. Fanelli was instructed to put her left foot on the line, then place her right foot on the line ahead of the left foot in a heel to toe manner. I then demonstrated this position. She was instructed not to begin untold to do so. Ms. Fanelli verbally indicated that she has understood all instructions up to this point. Ms. Fanelli was then instructed to take 3 heel to toe steps on the line when told to do so. I then demonstrated this. Ms. Fanelli was then instructed to turn on the ninth step and to keep the front foot on the line and to take a series of small steps with the foot on the line. I then demonstrated this. Ms. Fanelli was also instructed to keep her arms at her sides and to wetch her feet during the exercise. Ms. Fanelli was also instructed to count aloud and to not stop once she begins the exercise. She was also instructed to keep her arms at

Ms. Fanelli began the exercise too soon and had to be told to wait and to get back into the starting position multiple times. She began the exercise stepped off the line on all steps. Ms. Fanelli also did not count aloud and showed difficulty keeping balance. She used her arms for balance and caised them higher than 6 inches. Ms. Fanelli also completed the incorrect number of steps. While completing the turn Ms. Fanelli took both feet off the line and incorrectly completed the turn.

One Leg Stand Exercise

Ms. Fanelli was instructed to stand with her feet together and to place her arms down at her side. Ms. Fanelli was instructed to maintain that position until told to do so. Once told to do so, she was instructed to raise one leg approximately 6 inches off the ground and to keep both legs straight with both arms at her side. She was also instructed to look at the elevated foot and count aloud in the manner of one thousand-one, one thousand-two and so on until bild to stop. Ms. Fanelli verbally indicated that she understood the instructions after I demonstrated to her.

Ms. Fanelli was told to begin and raised her right foot. During the exercise Ms. Fanelli displayed an orbital sway and had to use her arms multiple times to keep from losing balance. She also did not raise her foot six inches off the ground or keep both legs straight. She raised her foot approximately 2 inches. Ms. Fanelli placed her foot down during the exercise multiple times and stopped the exercise. She did not look down at her foot during the exercise and count
