On the above date and time officers responded to Target (650 North Congress Ave) in reference to a theft in progress. Upon arrival loss prevention officer Bryan Vargas was following a white female wearing a black tank top out to the parking lot as she had just walked out of the store with a cart load of merchandise.

Vargas pointed to a Blue in color vehicle that the female later to be known as W/F Amanda Taylor (D.O.B. 05-06-81) got into. Officers did pull behind the vehicle a 2010 Blue Honda bearing FL temp tag BYB7233 at which time officers identified Taylor as the driver and sole occupant of the vehicle. Officers asked Taylor to step out of the vehicle at which time Vargas identified her as the female that walked out of the store with the merchandise.

Vargas stated he observed Taylor via CCTV and physical floor surveillance as she selected numerous items throughout the store and placed them into a shopping cart. Vargas stated Taylor concealed some items into a tower storage bin that Taylor brought inside of the store with her as well as placed items inside of the cart in plain view. Vargas stated Taylor walked into the in-store Starbucks area at which point Vargas stated Taylor appeared to be stalling to leave the store with the items. Vargas stated Taylor passed all points of sale without attempting to pay for the items inside of the cart. Vargas stated as Taylor walked out of the store, he followed her to the parking lot while he called BBPD. Vargas stated once Taylor got out into the parking lot, Taylor loaded the items into the trunk of her vehicle and was about to leave.

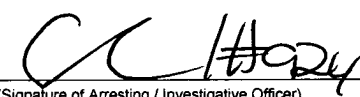
Upon officers looking into the trunk of the vehicle, Vargas identified the items inside as being the same ones Taylor stole from inside. Vargas was able to recover all of the items which had a total value of \$335.08. Taylor was handcuffed (D/L, checked for spacing) and told she was being placed under arrest for Retail Theft.

Vargas completed a sworn witness statement, was issued a case card, and stated video would be ready at a later date.

Based on the aforementioned I find probable cause to charge Taylor with one count of Grand (Retail) Theft pursuant to F.S.S. 812.014(2)(C)(1). An NCIC/FCIC check of records indicated no active warrants to Taylor. Taylor was later TOT to PBCJ. Nothing Further.
