P R O B A B L E C A U S E	On 04/06/2018 I observed a 2016 Mazda bearing Fl tag#EYMX21 run the stop sign at S Federal Hwy and E Royal Palm RD to go northbound on Federal Hwy. The Mazda then made a U-turn at a posted no U-turn sign at Palmetto and Federal Hwy to now go southbound on S Federal Hwy. I then conducted a traffic stop at 250 S Federal Hwy and met with driver Amanda Baureis. I advised her the reason for the stop and then asked her for her driver's license, registration and proof of insurance. Baureis provided me her Florida driver's license and registration paperwork but was unable to locate her insurance card. I then asked her where she was coming from and she stated that she was coming from Obrien's and she was going to her boyfriend's house. I then asked her how much she had to drink tonight and she stated that she had a few vodkas. Ofc Bohan and Ofc Codling arrived on scene and Ofc Alvarez arrived a short time after. While speaking with her I could smell an odor of an alcoholic beverage emanating from her person and her eyes were glossy and blood shot. I then asked Baureis to exit the vehicle.								
	Based on my observations I asked Baureis if she would submit to roadside sobriety tasks to dispel my alarm that she was under the influence. Baureis advised that she would submit to roadside tasks. I then walked her over to a well-lit area and asked her if she had any medical problems or medical issues that would prevent her from doing the tasks. Baureis advised that she had no medical or physical issues that would prevent her from conducting the tasks. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet.								
	The first SFST was the Walk and Turn. Baureis started the task and as she walked the line she failed to keep her feet heel to toe. She failed to count each step as instructed to do so. She took 10 steps forward and 9 steps back. She also made an improper turn by just turning around instead of the way that she was instructed. She also failed to keep her hands to her sides as instructed instead she placed her hands in front of her body and interlocked her fingers together.

The second SFST was the One Leg Stand. Baureis put her foot down during the task and she was swaying during the task. Baureis lost her balance during the task.

The third SFST was the Finger to Nose (L-R-L-R-R-L). Baureis on the first left touched the bridge of her nose. Baureis touched the tip of her nose on the first, second and third right. On the second left she touched the bridge of her nose and then brought her finger down to the tip of her nose. On the third left she used the pad of her finger to touch the tip of her nose. She also swayed during the task.

The fourth SFST was the Rhomberg Alphabet which she recited properly. Based on my investigation I placed Baureis under arrest for DUI. Ofc Alvarez searched Baureis and I then transported her to BRPD.

Ofc Reissi responded as my Breath Test operator. Ofc Reissi and I conducted the 20-minute observation and then she was taken into the BAT room. Baureis advised she would provide a breath sample then asked what would happen if she refused to provide a valid breath sample. I then read her Implied Consent Warnings and she advised that she would provide a sample. Baureis provided samples of .088 and .089. I also read Baureis her Constitutional Warnings which she advised she understood and she wouldn't answer my questions without an attorney present. See DUI influence report.

Baureis is being charged under F.S.S. 316.193(1) for DUI. She is also being charged for the violation of the traffic control device under F.S.S 316.074(1). Baureis was transported to Palm Beach county jail for final disposition. Baureis's vehicle was towed to Westway.
