On 8/19/16 I responded to 3098 Perry Avenue, Greenacres in reference to a battery. Upon arrival to the residence, I observed W/F Amber Minor (1/5/93) standing outside. I asked if she was the one who called, which she replied "no but I'm glad to see a police officer." When I asked what was wrong she stated nothing and does not know why PBSO was contacted. It should be noted that my observations of Minor led me to believe that she was possibly under the influence of an unknown type of drug or alcohol due to her dilated pupils (during mid day outside), her constant fidgeting and adjusting of her clothing.

I proceeded to ask her where Brittany was since that was the name I was advised by PBSO dispatch as calling. Minor stated she was inside the home. I then made contact with Brittany Davis (11/2/91) and she advised me that Minor struck her with a rolled up coloring book on the left side of her face. Davis's friend Alicia Martinez (6/5/98) advised that she witnessed this.

I exited the home to speak to Minor but she had fled in a SUV. I requested for Minor's mother to call her and have her return. Minor's mother made contact with the female who was driving the vehicle and I heard while on speaker phone that Minor was refusing to return to the residence. The driver then stated that Minor exited the vehicle in the area of Jackson Avenue, near Greenacres Elementary School. D/S Gilmore and I proceeded to that area to look for Minor but was met with negative results.

When I returned to the residence, I had Davis tell me more of what occurred. Davis said that Minor was yelling about how she does not like her. Davis does not know what provoked this due to her playing a app on her cell phone while sitting on the couch. Davis continued to say that Minor does have a "drug problem" and this could be a reason why she started yelling for no reason. Davis said that while she was playing on her phone, Minor approached her with a rolled up paper back coloring book and smacked her across the face with it before exiting the home. Minor had taken the coloring book with her when she left the residence.

Photographs were taken of Davis and placed into evidence. I advised them that if Minor returns to contact PBSO. Additionally Davis stated that she has no relationship with Minor and that they are only friends.

I made contact with Minor at her residence on 9/8/16. With this probable cause, I arrested her and placed her in the back of my marked patrol vehicle. Shortly after starting transporting to District 16 for paperwork, Minor began ranting about various things and spontaneously uttered "this is bull shit, she [Davis] gets to go to the club and suck my dad's dick, so yea I rolled up a coloring book and smacked her in the face."
