On 8/23/16 around 0200 hours, I was on routine patrol in my PBSO issued marked patrol vehicle (asset # 58806) the area of Canal 9 Road and S Military Trail, in unincorporated West Palm Beach, Palm Beach County Florida 33415. The below series of events was captured by my PBSO in car video system, will be classified as evidence, and uploaded to the PBSO web server.

I observed a Cream Colored Lincoln 4 door car bearing Florida tag 238RAH Travel Northbound on Military Trail from Canal 9 road without coming to a complete stop at the stop sign. I activated my overhead red and blue emergency lights, and initiated a traffic stop with the final resting place being the 4400 block of Purdy Lane. I made contact with the driver, Robert Dunn, whom I identified by his Florida Driver's License. Robert was ultimately issued citations for Driving under suspension with knowledge, and failure to stop at a stop sign. The rear passenger had a balled up piece of chore boy wire mesh that D/S Minissall identified from his training and experience as commonly used as a filter for smoking crack cocaine. The passenger admitted that it was for a crack pipe, and he admitted to tossing the crack pipe out but still had his metal pusher/cleaning rod. The front seat passenger admitted that there may still be drugs in the vehicle.

The back right passenger verbally identified herself as Crystal Trower. I observed Crystal holding her purse and a pack of 305 Cigarettes. I asked Crystal if I could look in her purse and she handed it over to me. Crystal continued to clutch her pack of 305 Cigarettes. I asked her to hand the cigarettes over to me, and she did. In the clear cellophane package outside of the cigarette packaging was a white rock looking substance that I identified from my training and experience to be crack cocaine. I later field tested the substance with a Duquenois cobalt and marquee test kit, and it tested positive for Cocaine. After her arrest, Crystal admitted that her name was in fact Amber Minor, and she gave me a false name because she thought she had a warrant.

Based on the above information, probable cause exists to charge Amber Minor with Violation of Florida Statute

893.13(6)(a) and 901.36(1).
