the door. A white female, later identified as Amber Fleming (DOB 08/03/1981,) answered the door where I immediately observed a large contusion on the right side of her face directly above her eye. Amber stated I may enter her residence where I made contact with white male Gerald Kenia (DOB 02/13/1978.) I asked Gerald how he was related to Amber and he stated he was married to her. I observed Gerald had minor scratches to his face which had minor blood on it.

I asked Gerald what happened tonight and he advised me that he had an argument with Amber. Amber confirmed this and stated that had an argument. I asked them if it had ever become physical and Gerald stated no, as did Amber. While speaking to Amber about what happened Gerald spontaneously uttered "just tell the truth we got into a fight."

I could smell the odors of the impurities of an unknown alcoholic beverage emanating from both subjects. Gerald appeared heavily intoxicated. Amber also appeared heavily intoxicated. Amber's jean pants were unbuttoned and hanging low, her hair was in disarray, and her shirt appeared stretched out, these signs appeared as though Amber had been in a physical confrontation and appeared disheveled.

I asked Amber how she obtained the contusion above her eye. Amber at first didn't answer and then became hysterical and crying stating that she had a cat and that the cat had caused the bruise. It is in this Officer's opinion that this bruise was caused by a strike from Gerald as it does not appear a cat could have caused this injury

I detained Gerald at this time, double locking handcuffs and checking for proper fit, and placed him into the rear of my patrol car.

I read Gerald his Miranda warnings off of my agency issued Miranda card. Gerald stated he did not wish to speak with me and requested a lawyer. I discontinued asking Gerald any investigatory questions at that time. I then read Amber her Miranda warnings off of my agency issued Miranda card. Amber stated she did not wish to speak with me at first but then stated she did. Amber then stated that she wanted to tell the truth and began crying hysterically, Amber stated she had pushed Gerald but would not say why she pushed him. When questioned if it was in self defense she said no.

I was unable to determine the primary aggressor in this situation however injuries were suffered to both persons and coupled with the caller's observations I feel there is probable cause to charge both Amber and Gerald with domestic battery.

Amber and Gerald were placed under arrest, double locking handcuffs and checking for tightness, and transported to LPD for processing.

Six digital photographs were taken documenting Gerald and Amber's injuries. While attempting to capture the photographs Amber repeatedly attempted to cover her injury. The photographs were placed into LPD evidence.

A request for a copy of the 911 call was placed to LPD dispatch.

Victim notification form completed for both Amber and Gerald.

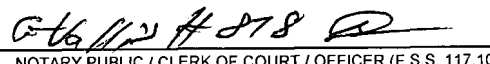
Amber was transported to Palm Beach County Jail by Officer Vallis and I transported Gerald to Palm Beach

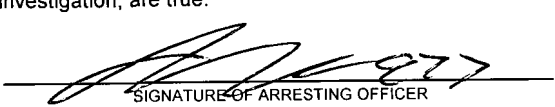
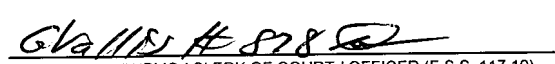
