On 8-5-2018 at approximately 1940 hours, I responded to the area of 599 E. Yamato Rd. in reference to a single vehicle accident investigation. The caller, Michele Nicholl, advised she observed a white vehicle collide with a pole along E. Yamato Rd. The vehicle was occupied by a W/F. Nicholl later completed a written statement which was placed into evidence. On arrival, I observed the driver of the vehicle, Amy Feehan, still sitting in the driver's seat of the vehicle. Feehan exited her vehicle and I could see that she was swaying. I walked up to her to make sure she was OK and was told by her that she was fine. While in close proximity of Feehan, I detected a strong odor of an alcohol beverage coming from her person, her speech was also slightly slurred. Feehan advised she was coming from the beach and traveling to her residence. Feehan stated she had not consumed any alcohol and was only "scared" after being involved in an accident. I then met with the Ofc. Bachar who advised he had just completed his accident investigation which revealed the following; the driver of V1, later identified as Amy Feehan, was driving a white Lexus vehicle bearing Fl Tag#DKR232 westbound on E. Yamato Rd. when she lost control of her vehicle which caused her to collide with a pole on the north side of E. Yamato Rd. Feehan did not have any significant injuries from the accident. V1 was later towed due to the damage. At this point I requested that Feehan walk to the front of my police vehicle (#381) so that I could ask her further questions. Once there, I read Feehan her constitutional rights from a pre-printed issued BRPD card. Feehan stated she understood and would speak without an attorney present. Feehan advised that she was the sole occupant inside of the vehicle when she collided with a pole. Feehan stated she lost control of her car because the tires were worn. Feehan informed me that she consumed two glasses of wine while at her place of work at 3 pm. I saw that Feehan was chewing gum in what I

believed was an attempt to mask the odor of alcohol.

Feehan advised that she is prescribed Gabapentin, Caprin and Xanax. She did not have any injuries.

I explained and demonstrated each task before she attempted them.

The first task was the Horizontal Gaze Nystagmus. While observing HGN, a lack of smooth pursuit was present in both eyes. Each eye had a constant jerking while at maximum deviation. Onset prior to 45 degrees was also present.

The second task was the Walk and Turn. She did not maintain the starting position. While listening to the instructions she was using her arms for balance and was stepping off the line. She did not go heel to toe at all. Feehan told me while listening to instructions that she was "trying this at work" earlier in the day. She continually stepped off the line while walking heel to toe and made an improper turn.

The third task was the One Leg Stand. Feehan did not count as instructed. She was swaying during the task and was using her arms for balance. She lost her balance several times.

The fourth task was the Finger to Nose (L-R-L-R-R-L). On the first and second finger to nose sequence she missed the tip of her nose.

The fifth task was the Rhomberg Alphabet. She completed this task with no issue.

At 2011 hours, I placed Feehan under arrest for DUI with property damage per F.S.S. 316.193(3C1). I transported her to the booking facility where I conducted the 20-minute observation period. Ofc. Bissoon responded to conduct the Intoxilyzer 8000. While in the DUI room, Feehan provided the breath samples of .155 and .154.

Feehan was medically cleared and later taken to the Palm Beach County Jail.

The vehicle was towed to Emerald Towing.
