evident throughout the encounter that Goldstein was unable to follow instructions.

While inventorying Goldstein's vehicle, I found a purple and pink plastic cup in the cup holder inside the vehicle next to the driver. The cup had a strong odor of an alcoholic beverage. Goldstein later stated that there was wine in the cup. The cup was placed into evidence.

At the PBCJ BAT, Goldstein agreed to submit to a testing of her breath after the 20-minutes observation period. Test results are as follows:
 Test 1: .157
 Test 2: .151

Due to the above stated facts, I believe probable cause exists to charge the defendant, Amy Goldstein, with Driving While Under the Influence pursuant to F.S.S. 393.193(1), and Open Container/Consumption in MV (driver) pursuant to F.S.S. 316.1936(2) (A). Goldstein was cited for Move Over/Slow Down for Emergency pursuant to F.S.S. 316.126(1) (B), Open Container/Consumption in MV pursuant to F.S.S. 316.1936(2) (A), and Driving While Under the Influence pursuant to F.S.S. 393.193(1).

Body Worn Cameras were worn by Officer Mohammed and I, and my in-car Camera of marked patrol vehicle #716 captured video of the incident. Goldstein's vehicle was towed by Westway.

WALK AND TURN: The defendant stated she understood my instructions. While listening to the instructions, Goldstein could not keep her balance, kept swaying, and could not stay in the instructional position she was initially asked to stay in due to lack of balance. Goldstein had to stop to steady herself, missed heel-to-toe on most steps, stepped off the line constantly, used her arms for balance, made an improper turn, and took an incorrect number of steps. I repeated the instructions several times, corrected Goldstein on her mistakes, allowed her the opportunity to try again, and still the same result.
