friends. Ames stated that they drove back to her residence at 2300 NE 5th Ave and got into an argument about another female. Ames stated that nothing physical occurred. But as she continued talking, she said "I beat his ass up there" and pointed to the front of the residence. I observed a broken window panel, which I photographed. Ames refused to say anything further and advised she was not going to get anyone into trouble.

- I then met with Officer Mazer, Officer Chriswisser, and Officer Galazka at 2180 NE 5th Ave., where they had stopped Eric Suarez, Jamie Bauer, and Jennifer Marino.
- I then met with Eric Suarez who advised he was out with his girlfriend, Amy Ames, and two other friends bar hopping. Saurez stated that he, Ames, Bauer, and Marino left the Whistle Stop Bar and Ubered to 2300 NE 5th Ave. Suarez advised that he and Ames got into a verbal argument and that nothing physical occurred. I observed a scratch on Suarez's right cheek and to the upper right side of his chest. Suarez stated he got the scratches when he tripped and fell onto the ground. I photographed Suarez's wounds and he provided a written statement.
- I then met with Jamie Bauer who advised when she, Suarez, Ames, and Marino arrived at 2300 NE 5th Ave., Suarez and Ames began to have a verbal argument. Ames and Suarez got out of the Uber and walked up to the front door. Bauer stated she saw the girlfriend "claw" at Eric's right chest and his head, but she did not want to put it in writing. Bauer attempted to get between them and break it up. Ames continued to scratch Suarez and Ames fell into the window causing it to break. Bauer provided a written witness statement.
- I then met with Jennifer Marino who refused to provide any information.

Based on my investigation, I placed Amy Ames under arrested in violation of F.S.S. 784.03(1A1) Simple Battery, Domestic. Ames complained of chest pains and was transported to BRRH then transported to Palm Beach County Jail.

Suarez was given a domestic violence pamphlet and the receipt was forwarded to BRPD records. The photographs and the written statements were submitted into BRPD evidence. The victim notification form was completed.
