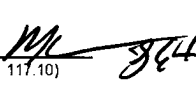

	On scene I made contact with Buteau who stated Kidwell is his live in girlfriend for over a year. Buteau added Kidwell was intoxicated was getting in his face and striking him all over his body. Buteau did not know why she was yelling at him. Buteau stated that he asked Kidwell many times to stop raising her voice and she would not listen and continue yelling at him more. Buteau added that he felt that she had also bitten him during the altercation. Buteau took off his shirt, and I observed a fresh bite mark on his upper right chest area concurrent with his statements. There were also minor scratches on his left arm. Digital photos of the injuries were taken and entered to LPD evidence. Contact was then made with Kidwell in the residence. Kidwell stated both parties were in a verbal altercation that became physical. When asked if Kidwell was struck she stated she had been manhandled. She stated Buteau grabbed her by the arms. There were no marks or bruises consistent with her statements At this time it was determined that Kidwell was the primary aggressor in this altercation due to the injuries sustained on Buteau. Kidwell was then placed under arrest. Handcuffed, double locked and checked for spacing Kidwell is being charged with simple battery (domestic). Kidwell was then transported to Lantana PD for processing and then transported to Palm Beach County Jail for booking. The 911 call made placed by Buteau was also placed into evidence. Buteau voluntarily signed a sworn statement, victim rights notification and a Domestic Violence Diagram.
