The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On 1/1/18, I was dispatched to 119 E Atlantic Ave (Tramonti Restaurant) regarding an unruly female. The manager, Glen Abood stated there was a w/f refusing to pay her tab and creating a disturbance inside of the restaurant. Abood stated she was harassing customers by accusing people of sexually harassing her and was live streaming the incident on Facebook. She was very loud, creating a disturbance and making multiple people around her upset as Glen received a few complaints from customers inside of the completely filled restaurant. Abood also said she finally paid after being asked multiple times and now refusing to leave the establishment while live streaming this on Facebook as well. Abood advised she had two glasses of wine and an employee at City Oyster (213 E Atlantic Ave) advised she had three Martinis also earlier in the night. Abood pointed her out and I made contact with her. When I made contact with her she had an almost empty glass of wine and the smell of alcohol coming from her breathe. I told her that the manager just wanted her to leave and there would be no further action. She refused to leave multiple times while still broadcasting our interaction on Facebook Live. She began getting more disorderly and loud which created the entire restaurant to focus their attention on her. She finally decided to leave but now shoving her phone in the managers face in which I thought she was attempting to hit him with it. I then tried to escort her out of the establishment and she shoved the phone in my face while doing so and screaming. Abood refused my lawful commands to leave the establishment. I then grabbed her hand with the phone in it and escorted her out of the restaurant while she was still screaming. She flailed her arms, starting to resist but I grabbed her arms and escorted her out. She tried to squirm out of my grip by rotating her body. When we exited the restaurant, Ofc. Barbire and I placed handcuffs on her.										
Based on the above facts, probable cause exists to charge Amy Rosenthal with Disorderly
