documentation involving this investigation (EXHIBIT # 1), all the documents scanned into Driver and Vehicle Information Database (D.A.V.I.D.) (EXHIBIT # 2), receipt of payment to the Palm Beach Tax Collectors Office (EXHIBIT # 3) for the transaction, and the surveillance video (EXHIBIT # 4) of Ana Luisa Diaz Blanco's driver license transaction. The following is a synopsis:

On January 12, 2018, Ms. Diaz Blanco walked into the Lake Worth Tax Collector's Office (P79-4215 South Military Trail, Lake Worth, FL 33463) and obtained a FL DL through fraudulent means from Examiner Norman Giddings.

- At 9:27 AM, Ms. Diaz Blanco (wearing a black shirt) can be seen entering into the view of the camera of the surveillance footage from Examiner Giddings' left with an unidentified female.
 Both females take a seat in the waiting area near the entrance.
- At 9:43 AM, the unidentified female (with Ms. Diaz Blanco behind her) approaches Examiner Giddings' work station. The unidentified female hands Mr. Giddings Ms. Diaz Blanco's learners license.
- At 9:44 AM, Ms. Diaz Blanco signs the Record of Driving Examination Score Sheet handed to her by Examiner Giddings.
- At 9:47 AM, Examiner Giddings places the examination score sheet inside the scanner.
- At 9:49 AM, Ms. Diaz Blanco stands in front of the pillar and has her driver license photo taken by Examiner Giddings.
- At 9:50 AM, Examiner Giddings instructs Ms. Diaz Blanco to sign the magnetic pad.
- At 10:02 AM, Ms. Diaz Blanco hands Examiner Giddings cash.
- At 10:03 AM, Examiner Giddings places the cash in the cash drawer.
- At 10:04 AM, Examiner Giddings grabs Ms. Diaz Blanco's fraudulently obtained driver license (DL# D214-012-73-834-0) and hands it to the unidentified female. Ms. Diaz Blanco and the unidentified female exit the building.

Examiner Giddings never had Ms. Diaz Blanco perform the standard eye examination required prior to being issued a driver license, nor did Ms. Diaz Blanco ever leave the counter to perform a proficiency driving test in front of a DL examiner. A review of the documents through D.A.V.I.D., revealed that when filling out the exam score sheet, Giddings marked that Ms. Diaz Blanco did not commit any errors. Ms. Diaz Blanco was never entered in the Master Log for the road test (EXHIBIT # 6), which is required to be filled out for all road test taken that day. The tag Giddings used for the Driving Examination sheet was FL tag Y67RHE, registered to Hector Efrain Reyes out of Lake Worth.

D.A.V.I.D. reflects that Ms. Diaz Blanco attained a learner's license (EXHIBIT # 7) on February 10, 2018.

On November 20, 2018 Trooper Ramon Fernandez, Trooper Ryan Fernandez, attempted to locate Ms. Diaz Blanco at the residence listed on her driver's license (2844 Floweva Street, West Palm Beach, Florida 33506). When they arrived at the residence they made contact with a female who stated she was Ms. Diaz Blanco's mother in law. She called Ms. Diaz Blanco over the phone and allowed Trooper Ramon Fernandez to speak to her. Ms. Diaz Blanco stated that she lived at 2271 Pinecrest Court, Apt # 2, West Palm Beach, Florida.

Trooper Ryan Fernandez and Trooper Ramon Fernandez made contact with Ms. Diaz Blanco at her
