P R O B A B L E	On 2/24/18 at approximately 1156 hours, I was dispatched to 806 Southview Dr. in reference to a domestic disturbance. Upon my arrival I made contact with Cesar Tambriz (W/M DOB: 6/11/93), who stated the following:						
	On 2/24/18 at approximately 1100 hours, he arrived at 804 Southview Dr. to pick up his girlfriend, Ana Montes-Alvarado (W/F DOB: 1/27/81). At approximately 1146 hours the couple began to argue, so Tambriz went next door to 806 Southview Dr. to get away from Montes-Alvarado. The argument continued at this address until the owner, Maritza De Leon (W/F DOB: 2/12/65), asked both parties to leave. When De Leon began to escort Montes-Alvarado out, Montes-Alvarado turned around and pushed De Leon into a broken window. After speaking with Tambriz I made contact with Montes-Alvarado, who stated the following:						
	Montes-Alvarado and her boyfriend were in an argument which ended up at the neighbor's house where they continued to argue. As they were arguing De Leon grabbed Montes-Alvarado by her hair and began to push her. Montes-Alvarado broke free, grabbed De Leon's hair and pushed her. Montes-Alvarado could not provide me with any further information. After speaking with Montes-Alvarado I spoke with the victim, De Leon, who stated the following:						
	On 2/24/18 at an earlier unknown time, Montes-Alvarado was in her house and broke one of her windows (valued at \$150). Later in the day at approximately 1146 hours, Tambriz came over to get away from Montes-Alvarado. Montes-Alvarado came into the house and began to argue with Tambriz for a couple of minutes. After a couple of minutes De Leon stated she had enough of the arguing and started the escort Montes-Alvarado out. All of a sudden Montes-Alvarado turns around, grabs De Leon by her hair and pushes her against the broken glass, causing a small laceration in her armpit. Montes-Alvarado left shortly after this occurred and De Leon had her son, Uriel Lopez-Bravo (W/M DOB: 7/25/93), call

After speaking with De Leon I made contact with another witness, Lopez-Bravo, who stated the following: On 2/24/18 at an unknown earlier time, Montes-Alvarado was in his house and broke one of the windows. Montes-Alvarado left the house, but came back shortly when Tambriz came over. When both parties were present they began to yell and argue very loudly. Lopez-Bravo's mother De Leon began to escort Montes-Alvarado out of the house. Montes-Alvarado turned around, grabbed De Leon by her hair and pushed her into the broken window causing a small laceration to De Leon's armpit. Montes-Alvarado left shortly after and he called the police. After speaking with Lopez-Bravo, I made contact with the other witness, Brian Morales (W/M DOB: 9/16/2002), who stated the following: Earlier in the day Montes-Alvarado came over the house and broke a window and left. Tambriz came over the house a short while later to get away from Montes-Alvarado. Montes-Alvarado came back and began to argue with Tambriz. After a couple of minutes, De Leon decided to escort Montes-Alvarado out of the house. Montes-Alvarado turned around, grabbed De Leon by the hair and pushed her into the window. Montes-Alvarado left shortly after. Due to the above facts collected from my investigation I find probable cause to charge Ana Montes-Alvarado with: BATTERY Ana Montes-Alvarado did actually and intentionally touch or strike Maritza De Leon against the will of Maritza De Leon (or) did intentionally cause bodily harm to Maritza De Leon contrary to Florida Statute 784.03(1). (1 DEG MISD) CRIMINAL MISCHIEF (\$200.00 or less) Ana Montes-Alvarado did willfully and maliciously injure or damage, or place graffiti thereon, or commit an act of vandalism to house window the property of Maritza De Leon, contrary to Florida Statute 806.13(1)(a) and (b)1.
