When both parties were present they began to yell and argue very loudly. Lopez-Bravo's mother De Leon began to escort Montes-Alvarado out of the house. Montes-Alvarado turned around, grabbed De Leon by her hair and pushed her into the broken window causing a small laceration to De Leon's armpit. Montes-Alvarado left shortly after and he called the police. After speaking with Lopez-Bravo, I made contact with the other witness, Brian Morales (W/M DOB: 9/16/2002), who stated the following: Earlier in the day Montes-Alvarado came over the house and broke a window and left. Tambriz came over the house a short while later to get away from Montes-Alvarado. Montes-Alvarado came back and began to argue with Tambriz. After a couple of minutes, De
