On 07/14/2017, at approximately 0100 hours, Ofc Bissoon and I observed a silver 2012 Toyota Corolla bearing Fl tag# DPR38 driving with the front right headlight out travelling southbound in the area of 7200 N Dixie Hwy. I followed the vehicle and observed it swerving to the right of its lane, in and out of the lane numerous times. The vehicle stopped at the intersection of N Dixie Hwy and E Yamato Rd in the left through lane on N Dixie Hwy. The traffic lights turned green for southbound traffic, but maintained a red arrow for the left turn lane. The vehicle accelerated, and ran the redlight. I activated my lights and conducted a traffic stop in the south parking of 500 NE 51st St. (Checkers).											
Ofc. Bissoon and I exited our patrol vehicle and approached the vehicle. As we approached, the vehicle began to move again. Ofc. Bissoon instructed the driver to stop the vehicle, place it in park, turn it off, and remove the keys from the ignition. Ofc. Bissoon informed the driver of the reason for the stop. Ofc. Bissoon then asked the driver, identified as Ana Gore by her FL DL, for her driver's license. Gore initially could not located her driver's license, but eventually found it in her wallet. While Gore was looking for her license, Ofc. Bissoon noticed another Florida Driver's License in Gore's wallet. Ofc. Bissoon asked Gore what the license was, to which Gore replied it belonged to her sister. When asked, Gore could not identify the name of the person on the second driver's license or the listed address. Ofc. Tyson and Ofc. Chriswisher responded as my backup.											
While speaking with Gore, Ofc. Bissoon noticed the smell of an alcoholic beverage emanating from Gore's breath and that her eyes were glossy and bloodshot, and that her speech was slurred. Ofc. Bissoon asked Gore if she had been drinking tonight, to which she replied she had. Based on his observations, Ofc. Bissoon asked Gore to step out of the vehicle. Ofc. Bissoon then explained to Gore his suspicion that she may be intoxicated and asked if she would voluntarily consent to preform roadside sobriety

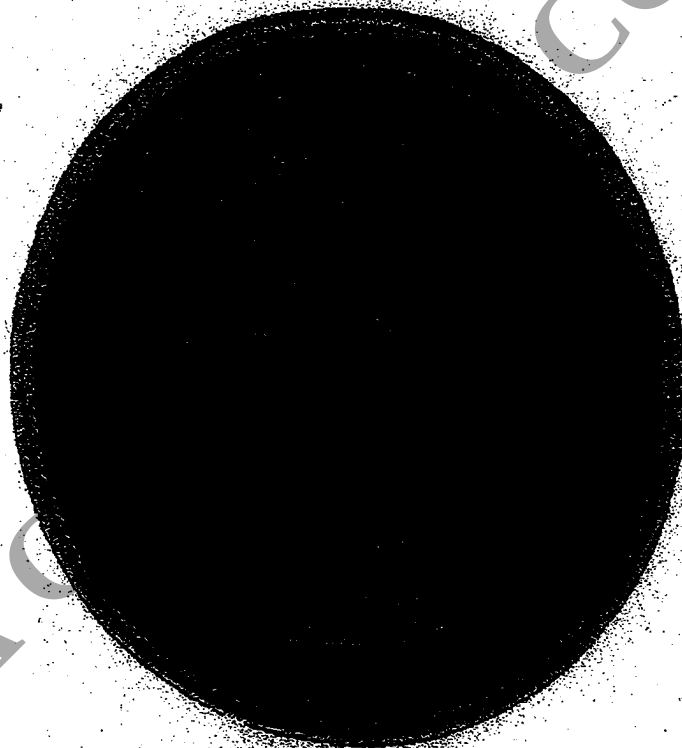

tasks. Gore verbally indicated she understood and stated she would consent to the tasks. I directed Gore to stand on a yellow parking line in the parking lot. As Gore walked from her car to the line, she stumbled several times. I then gave Gore the instructions and demonstrated the first roadside sobriety task, which was the Walk and Turn. Gore stated she understood all the instructions. Gore began the task before being told to do so. While performing the task, Gore missed heel to toe on every step and also did not turn around properly. I then gave Gore the instructions for the One Leg Stand. As I began to explain the task, Gore informed me she recently had hip surgery. Given Gore's recent hip surgery, I chose for Gore to not perform the one leg stand. I gave Gore the instructions for and demonstrated the Finger to Nose task. Gore indicated she understood the instructions. Gore began the task, and initially started with her right index finger when I called for her left index finger. Gore left her finger on her nose until I prompted her to remove her finger. On ever following command, Gore left her finger on her nose until I called for the next finger. When I called for her right finger twice in a row, Gore used her left finger before correcting herself and using her right finger. I then gave Gore the instructions for the Rhomberg with Recitation. I asked Gore for her current level of education and if she was familiar with the English Alphabet. Gore stated she is currently in college and is knows the English alphabet. Gore conducted the test, but did not follow my directions and recited the alphabet in song form. Based on my investigation, I placed Gore into custody. I then transported Gore to BRPD. Ofc. Murphy responded to BRPD as my Breath Test Operator. Ofc. Murphy and I conducted the 20 minute observation and then she was taken into the BAT room. Gore consented to the breath test. Gore's first B.A.C. reading was .197 and the second was .195. I read Gore her Constitutional Warnings and she stated she would be willing to speak with me. See D.U.I. Influence Report. A search incident to arrest was conducted, during which Ofc. Chriswisher found a glass pipe in Gore's purse. Post Miranda, Gore stated the pipe was hers and claimed she uses it to smoke marijuana. Gore's vehicle was towed by Westway towing. Gore is being charged under F.S.S. 316.193(1) for DUI and for possession of drug paraphernalia in violation of F.S.S. 893.147(1b). She was also given a citation under F.S.S 316.075(1c1) for failure to stop on a steady red light. The video footage and was submitted into BRPD evidence. The second driver's license was forwarded to the DMV. Gore was transported to the Palm Beach County Jail for further processing and the vehicle was towed by Emerald towing.
