ON 09/17/17, AT 2305 HRS, I WAS DISPATCHED TO 22373 SW 66TH AVE IN REF TO A CALL OF A WIFE FEMALE CHASING A WHITE MALE WITH A KNIFE. UPON ARRIVAL I BEGAN TO BOLO THE AREA. WHEN I WAS PASSING 22277 SW 66TH AVE I HEARD A WOMEN SCREAMING SOMEBODY CALL THE COPS. I TURNED AROUND AND OBSERVED A W/M WALKING DOWN THE STEPS AND A W/F ON THE SECOND FLOOR STATING THAT HE ATTACKED HER. THE W/M WAS ID AS ANDERSON CORREIA DA SILVA AND THE W/F WAS ID AS BRITTANIE SILVA.

DA SILVA WAS DETAINED UNTIL I COULD FIGURE OUT WHAT HAD HAPPENED. I THEN MET WITH BRITTANIE SILVA IN APT 1908. BRITTANIE STATED THE FOLLOWING.

SHE STATED THAT SHE AND HER HUSBAND ANDERSON GOT INTO A VERBAL ARGUMENT THAT QUICKLY ESCULATED TO A PHYSICAL ALTERCATION BETWEEN THEM. SHE ADVISED THAT SHE WAS IN THE KITCHEN GETTING FOOD FOR HER TWO CHILDREN WHEN ANDERSON BEGAN TO YELL AT HER FOR THEIR SON NOT EATING PROPERLY. SHE PLACED A KNIFE INTO SINK AND ANDERSON PICK IT UP FEARING THAT ANDERSON WOULD USE THE KIFE SHE GRABBED IT AND SLICED HER FINGER. THE ARGUMENT CONTINUED TOWARD THE MASTER BEDROOM WHERE THE TWO CHILDREN WERE WATCHING TV. ONCE IN THE BEDROOM ANDERSON PUSHED HER DOWN ON THE BED AND HELD HER DOWN BY HER ARM AND THEN HE PLACED HIS HAND NEAR HER NECK TO HOLD HER DOWN. ANDERSON THEN GOT OFF OF HER AND EXITED THE APARTMENT WHERE SHE BEGAN TO YELL FOR HELP.

I THEN SPOKE TO BRIANNA L DA SILVA THEDUGHTER OF BOTH PARTIES. I ASKED HER WHAT SHE SAW SHE SAID SHE SAW DADDY PUSH MOMMY ON THE BED AND HOLD HER DOWN.

I THEN SPOKE WITH ANDERSON WHO STATED THAT BRITTANIE WAS THE ONE WHO ATTACKED HIM HE WAS JUST TRYING TO FEED THEIR SON WHEN SHE CAME AT HIM WITH A KNIFE. HE STATED THAT SHE CHASED HIM AROUND THE APT AND THEN THEY BEGAN TO ARGUE AGAIN. HE THEN LEFT THE RESIDENCE AND OBSERVED A NEIGHBOR WALKING A DOG AND TOLD HIM THAT HIS WIFE WAS CHAING HIM WITH A KNIFE. AFTER BEING OUTSIDE FOR A FEW MINUTES HE REENTERED THE RESIDENCE TO GET HIS KEYS AND WALLET SO HE COULD LEAVE.

THE WITNESS WHO WISHED TO REMAIN ANONYMOUS ADVISED THAT HE DID NOT SEE THE FEMALE CHASING THE MALE WITH A KNIFE. HE WAS GOING BY WHAT THE MALE HALF TOLD HIM.

WHEN I OBSERVED BRITTANIE I OBSERVED THAT SHE HAD MARKS AROUND BOTH BICEPS AND NEAR HER NECK. SHE ALSO HAD THE CUT TO HER FINGER FROM WHEN SHE GRABBED THE KNIFE. I DI DNOT OBSERVE ANY OTHER INJURIES.

BASED ON MY INVESTIGATION I HAVE PROBABLE CAUSE TO ARREST ANDERSON CORREIA DA SILVA FOR DOMESTIC BATTERY.

Brzenski got information from Brittany as well as their 5 year old daughter stating that Mr. Silva was the agressor and started by pushing Brittany down onto the bed. Sgt. Brzenski relayed to me that Mr. Silva and Brittany got into a verbal argument that turned physical, Mr. Silva then pushed Brittany down onto the bed and was holding Brittany down around her upper chest area not allowing her to get up.
