Mr. De Lucchi was swaying in a circle and eventually rested himself against the front of his vehicle.

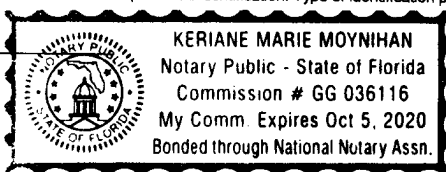

ONE LEG STAND:

THE DEFENDANT WAS PLACED INTO THE INSTRUCTIONAL STANCE FOR THE ONE LEG STAND AND GIVEN INSTRUCTIONS. THE DEFENDANT STATED THAT HE UNDERSTOOD THE INSTRUCTIONS. THE DEFENDANT STARTED BEFORE I TOLD HIM, HOPPED, DID NOT COUNT OUT LOUD, USED HIS ARMS FOR BALANCE, ATTEMPTED THE TASK SEVERAL TIMES

FINGER TO NOSE:
