
I responded to 430 La Mancha Ave., in reference to a suspicious black SUV parked in front of the callers driveway to her residence occupied by a unknown subject.

I could smell a strong odor of alcohol omitting from the interior of Albarran's vehicle and I could see a empty liquor laying on the front passenger seat. D/S Landa asked Albarran if he had any thing to drink and Albarran replied yes.

Based on the above observations I believed that Albarran was impared to drive or be in control of his vehicle. I requested for a DUI investigator to respond to my location for further investigation in this incident.
