ADMINISTRATIVE	told Andrew he no longer had a job. Andrew begged Juan to give him another chance, but Juan told Andrew he										
	was unable to give him any more chances since he has given him plenty in the past. Juan then asked Andrew to										
ADMINISTRATIVE	give his portable hand held radio back. As Andrew was handing Juan the radio back with his right hand, he										
	punched Juan in the nose with his left closed fist causing Juan to fall to the ground and become unconscious.
