On the above date and time I responded to 7392 ASHLEY SHORES CIR in reference to a domestic battery. Upon arrival I met with complainant/victim Jennifer Defalco. Jennifer appeared very upset and scared when she exited her vehicle which she was waiting in. Jennifer told me that the morning of 8/18/2017 she took her kids to school, grabbed a cup of coffee then returned home. Jennifer stated that her ex boyfriend Andrew Weingrad's white BMW was parked outside of her residence which shocked her since they agreed to part ways for a while. Jennifer explained that she walked inside her residence and saw Andrew sitting at the dining table on his laptop. Jennifer said that she asked Andrew why he was in the house and he said that they needed to talk about their relationship. Jennifer said that she told Andrew that she was tired and she wanted him to leave but Andrew refused. Jennifer stated that she told Andrew she would leave if he would not and then Andrew grabbed the back of her shirt and hair. Jennifer said that she ran to her bedroom and Andrew threw her on the bed and restrained her from leaving. Jennifer stated that she told Andrew that she was scared and he was hurting her. Jennifer told me that Andrew let her go and ran into her bedroom drywall, cracking the wall. Jennifer stated that Andrew picked up a glass cup containing water and threw it at her. Jennifer told me that as Andrew turned around she ran out her master bathroom door then out her screen enclosure door towards her neighbors residence located at 7388 Ashley Shores Circle. Jennifer stated that her Neighbors were not home at the time so she dialed 911. Based on my investigation and statements from all parties involved and the witnesses I find probable cause to arrest Andrew Weingrad for domestic battery as Andrew did actually and intentionally touch or strike Jennifer Defalco against the will of Jennifer Defalco and did intentionally cause bodily harm to Jennifer Defalco and Jennifer Defalco was a family or household member of Andrew Weingrad, contrary to Florida Statute 784.03(1) and 741.283 (1 DEG MISD) Andrew Weingrad was placed into handcuffs in the rear per department policy, checked for tightness and proper fit and double locked with no complaint of injury. Andrew Weingrad was advised that he was being arrested for domestic battery.
