DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Thursday, June 21, 2018 at approximately 0020 hours, while patrolling southbound on Seminole Pratt and Whitney Road, South of Northlake Avenue, Loxahatchee (Palm Beach County) Florida I stopped a white pick up truck for excessive speed. During this incident I heard a loud and steady high pitch sounding from my Radar's audio Doppler displaying a speed of 74 miles per hour (mph) in a posted 45 mph speed zone. A pick up truck was traveling northbound toward me whereas its speed matched the tone of the Doppler and speed displayed in the target window. As the vehicle passed me the Doppler ceased in sounding and the target speed vanished from the target window. I made a U-turn and proceeded northbound to overtake the vehicle for the speed violation. I also switched my unit to the "front same" mode which captured the target vehicle's speed while overtaking it. Once behind the pick up truck I received an increased speed of 90 mph. I activated my emergency lights in an effort to conduct a traffic on the vehicle. The vehicle made an abrupt lane change into the right turn lane and negotiated a wide right turn onto Northlake Ave. from Seminole Pratt. It traveled a short distance eastbound before abruptly pulling over onto the south shoulder of the roadway. I approached the pick up from the passenger side and made contact with a white male subject who was the sole occupant and sitting in the driver seat.

OBSERVATION OF DRIVER:

The driver was later identified as Andrew Edward Brockmeyer by his Florida driver license. I asked for his driver license, registration and proof of insurance. He handed me the items. I told him he was stopped for excessive speed, being initially clocked at 74 mph and increasing his speed to 90 mph. I later asked where was he coming from and he told me The Gator Shack. He admitted to having two beers there. During my interview I noticed his eyes were red, watery and glassy. His cheeks were flushed and mouth was dry. He slurred his speech while speaking. I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the vehicle. I told the driver I had a suspicion that he had been drinking an unspecified amount of alcoholic beverages. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He consented to performing the SFSTs. Prior to exiting the vehicle I asked if they had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant told me he has disc issues in his back. He told me he is on medication for this problem. (At the breath facility however, the defendant told the breath technician he has nothing wrong with him other than mental problems). I asked if he was employed and he told me he is a mechanic. I asked him to exit the vehicle and noticed he was unable to maintain his balance. He extended his arm and leaned against his truck to support himself. I asked him to step away from his vehicle and onto the roadway. He turned his back to me and placed his hands together as if to be handcuffed. He later told me he would not pass the SFSTs. I told the procedure is not a pass or fail, but is an evaluation which would assist me in making a determination of him being impaired. I escorted him to a smooth and level surface that was free from obstructions and debris. The area was well lit by the lights from my patrol car. I asked him to identify with the white edge line. He successfully identified the line by placing his left foot on it when asked. I could now smell a strong odor of an unknown alcoholic beverage emanating from his breath. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. He did not complete the Walk and Turn. He complained of having balance problems due to his disc issues. He did not attempt the One Leg Stand. His deficiencies were recorded on another form on this worksheet. At the conclusion of the SFSTs, coupled with my observation of the defendant's vehicle in motion, coupled with my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI.

DRIVER'S STATEMENTS:

I had a couple of beers. I messed up. It is my fault and I did this to myself.

STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM SUBJECT'S BREATH.

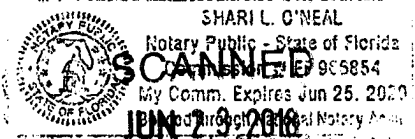

Other Observations:

Subject was asked to sit on my front bumper. He was asked to focus on the stimulus and follow it with his eyes. Lastly he was told not to move his head to assist in following the stimulus with his eyes. Subject showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation. I also saw an onset of Nystagmus prior to 45 degrees in both eyes.

WALK & TURN:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE WALK AND TURN. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain his balance while placed in the instructional position. He swayed and ultimately abandoned the position all together. He later told me he has balance issues from his disc problem and would not perform this task.

ONE LEG STAND:

Refused this task citing balance problems from disc issues in his back

FINGER TO NOSE:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE FINGER TO NOSE. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while placed in the instructional position. He failed to touch the tip of his finger to the tip of his nose on all six attempts. Rather he touched the bridge, each sides of his nostrils and underneath his nose.

ROMBERG ALPHABET:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ROMBERG ALPHABET TASK. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while performing this task. He failed to recite the 26 letter alphabet on one attempt.

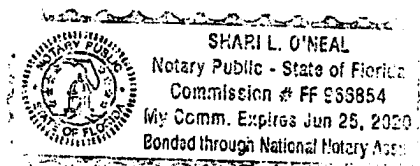

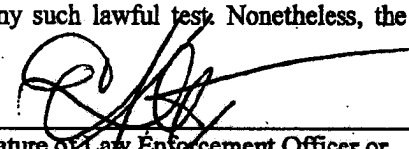

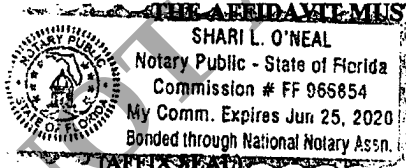
