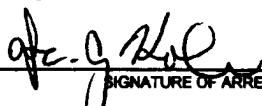

NARRATIVE

Danielle advised that they have been arguing and fighting all morning. She said that around 0900 hours today, Andrew grabbed her and dragged her on the downstairs floor and then threw her onto the couch, starting screaming at her and pulled off her pants and shirt. She was crying and begging him to leave her alone. She said that when he was dragging her she grabbed his neck to defend herself in hopes of Andrew releasing her. She was able to get away from Andrew and ran upstairs to her bedroom. Several minutes later Andrew came upstairs and grabbed her by her breasts and then pulled her off the bed by her feet. Once she was on the floor he grabbed her by the neck and started to bang her head on the floor. She said she never lost consciousness but that she did feel lightheaded from him banging her head on the ground. She also said that her airway was never restricted when he grabbed her by the throat. He then let go of her, however, they continued to argue and then at approximately 1200 hours Andrew was breaking items in the house. Danielle went to get the vacuum so that she could clean up so the dog would not eat any of the broken pieces that were on the floor. She advised that he got mad that she was vacuuming so he picked up the vacuum and threw it at her and then he began to whip her with the cord striking her arms. This is when Danielle called Andrew's mother, Jane Brodsky, on her cellphone, who then called BRPD asking for help. Jane did not witness any part of this disturbance. She was never at the residence. Danielle had bruising on both breasts, a red mark on the side of her neck, red marks on her chest, red marks on both arms and bruising on her buttocks. These injuries are consistent with her account of today's incident. Danielle refused to complete a sworn written statement, however, all information was recorded on the body worn cameras worn by Ofc. Schuss, Ofc. Rodgers and myself. All video has been submitted into evidence.

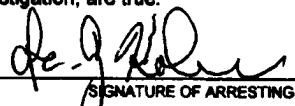
I then spoke with Andrew Brodsky who advised that he and Danielle have been arguing all morning since approximately 0900 hours. He is stating that Danielle grabbed him by the throat because she was frustrated with him due to all the yelling and screaming between the two of them. He did have a mark on the left side of his neck that is consistent with him being grabbed by the neck. Andrew had no other injuries or marks on his body.

They both advised that they have been dating and living together for 1.5 years at this residence.

My investigation revealed that Andrew was the primary aggressor and violated FL. State Statute 784.03(1a1). He was placed under arrest, processed at BRPD and then TOTCJ.
