PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I responded to a crash that occurred at the intersection of North Alternate A1A and Old Dixie Highway. Officers from Tequesta were already on scene. Louis Lamm advised that a male later identified as Andrew Ritter was driving erratically behind his friend, Diana Lawrence. Lamm was in the passenger seat. Lamm advised that he told Lawrence to pull over to let the reckless vehicle pass. Ritter's vehicle, a 2007 Dodge truck bearing Florida License Plate HIGQ12, struck Lawrence's vehicle's rear passenger side bumper with its front driver's side bumper. Lamm made contact with Ritter at the next traffic light and seized his keys. Lamm advised he could smell the odor of an unknown alcoholic beverage when he spoke to Ritter.

Upon my arrival, Ritter was in the driver's seat of his vehicle. I spoke briefly to Lamm and Officer Hobby, who was already on scene.

OBSERVATION OF DRIVER:

When I spoke to Ritter, I immediately noticed he appeared to be crying, with tears running down his cheeks. Ritter's speech was severely slurred. I could smell the odor of an unknown alcoholic beverage on Ritter's breath. Ritter had bloodshot, glassy eyes.

DRIVER'S STATEMENTS:

Post Miranda, Ritter stated he was unable to avoid the crash after the vehicle in front changed lanes. Ritter stated he had consumed three Guinness Beers at a work party during the prior three hours. Ritter stated he was a "2" on a scale of 1-10 as it related to impairment.

ODORS:

Odor of unknown alcoholic beverage on his breath.

GENERAL OBSERVATIONS

SPEECH: Slurred, mumbled

ATTITUDE: Mostly cooperative, mood swings, occasionally belgierent and argumentative.

CLOTHING: Polo shirt with stripes, jeans, blue sneakers

MEDICAL/OTHER: Difficulty hearing out of right ear.

Other Observations:

LOC was observed.

WALK & TURN:

Ritter lost his balance in the starting position several times. Ritter stopped after the first step. Ritter missed heel to toe on the 4th and 6th steps. Ritter stepped off the line to the right on the 7th step. Ritter took eight steps. Ritter turned improperly, pivoting on the balls of his feet. Ritter missed the line on the first step. Ritter missed heel to toe on the third step. Ritter stepped off the line to the right on the fourth step. Ritter missed the line on the seventh step. Ritter used his arms for balance several times during the return leg. Ritter was notably unsteady on his feet.

ONE LEG STAND:

Ritter raised his foot and put it down on "1000-1". He tried again, counting to "1000-2" before declaring that he could not do the task.

FINGER TO NOSE

Ritter stated he did not wish to continue. I explained what the next tasks were and he agreed to continue. Ritter stated "You already got me!" during the explanation of the task. L1: Ritter touched the tip of his nose. R2: Ritter touched his nose over his right nostril before moving it to the tip. L3: Ritter used the pad of his finger and touched the tip of his nose. R4: Ritter touched the tip of his nose. R5: Ritter used the wrong finger at first then corrected himself. Ritter touched under the tip of his nose in between his nostrils. L6: Ritter touched the tip of his nose as instructed.

ROMBERG ALPHABET:

Ritter was swaying visibly during the task. Ritter stated the alphabet as follows: A B C D E F G H I J K L M N O P Q R S T U V W X Y Z.

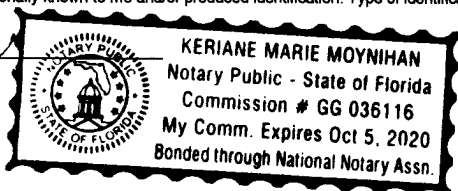
