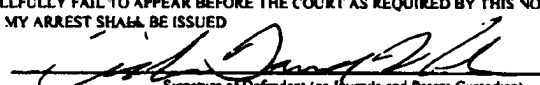
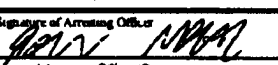

The following incident occurred in the city of Delray Beach, Palm Beach County, Florida. On 05/23/18 at 0225 hours, I was dispatched to 1203 NE 2nd Ave in reference to a disturbance. The victim (David Fleishman) was standing outside separating himself from the suspect (Andrew Umlor). Fleishman stated the residence was starting to flood from the toilet and he asked Umlor to help clean up the mess. Umlor stated he would clean tomorrow instead of helping all the other house mates. Fleishman replied that everyone was helping clean except you. Umlor told him again that he would clean tomorrow. As Fleishman took a seat on the couch Umlor approached him and asked him if "You want to go again". Umlor made contact with Fleishman's face and grabbed the prescription glasses off of Fleishman's head and threw them against the wall breaking them into three pieces. Fleishman did not sustain any injuries and refused medical attention. I found the glasses on the floor in three separate pieces. The victim estimates the glasses to be worth \$450. Based on the following facts, probable cause exists to charge Andrew Umlor with Simple Battery (784.03(1A1)) and Criminal Mischief over 200 under 1000(806.13(1B2)).
