D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

Andrew Pardo was driving a Ford Mustang bearing Florida tag IH20LW on Westbound 6800 block of Palmetto Park Road, in unincorporated Boca Raton Palm Beach County. He then collided at high speed with a Chevrolet bearing FL tag Y65USM driven and registered to Guillermo Jean Higinio who was driving in the same direction ahead of him. The Chevrolet was pushed over the median and sustained heavy damage. Jean Higinio sustained moderate injuries in the crash. The Mustang also drove over the median and sustained heavy damage. Immediately after the crash, Pardo exited the vehicle and went to check on Higinio. He then went back to his vehicle attempting to start it again. Chadwick Timothee who arrived immediately after the crash, observed Higinio behind the wheel of the Ford Mustang.

OBSERVATION OF DRIVER:

Pardo was very lethargic. He had an unsteady gait and appeared oblivious to his surrounding. During the crash investigation we had multiple time to refrain him from walking into the traffic.

DRIVER'S STATEMENTS:

Post Miranda would admit being the driver at the time of the crash. Admitted having been drinking at least two beers that he could remember in the last few hours with his friends.

ODORS:

Slight odor of unknown alcohol beverage that become stronger when he talked.

GENERAL OBSERVATIONS

SPEECH: Very low, mumbled

ATTITUDE: cooperative, forgetful, repetitive

CLOTHING: white striped shirt, blue shorts, blue sneakers

MEDICAL/OTHER: denied any medical condition

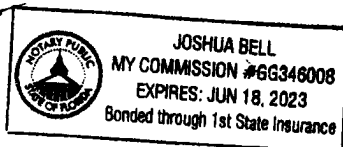

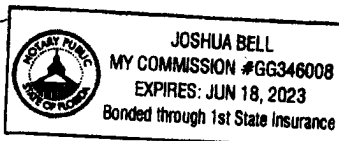
