I responded to the Lake Worth Municipal Beach in ref. to a subject who was later identified as Andrew P. Schneider, threatening C.SO. Larry Farber. On my arrival I met with Farber who pointed out Schneider on the beach boardwalk and said that schneider confronted him about a parking citation that he received the day before and demanded that Farber take the citation back. Farber said that when he refused, Schneider became angry and told Farber that if he took the uniform off he would "kick his ass" he also called him a scum bag and the shit under my foot. Upon contact with Scheider he was rude, profane and disruptive and argumenative. He said Farber was a liar and said he had his freedom of speech. I told Scheider that his behavior was disruptive, and as an authorized deputy, I told him to leave the Municipal Beach. Schneider refused and continued to argue with me. I warned him several more times and he said he would not leave because he has his rights. Schneider was placed under arrest for trespassing after being warned, under F.S.S. 810.09. he was handcuffed per policy and T.O.T. C.J.
