PROBABLE CAUSE

I was on the left shoulder of SR-9 (I-95) northbound on top of 45th St. Defendant was driving in the right center lane northbound, passing a car at an estimated speed of 80-85 mph in a posted 65. I clocked defendant with radar at 83 mph. As I entered traffic to overtake defendant he slowed and moved to the right lane, then accelerated again, moving to the right center lane, overtook a car and drifted to the center lane, partially into the left center lane, then back to the right center lane. I clocked defendant again, now with moving radar at 84 mph. I activated my emergency lights and defendant braked but remained for several seconds in the right center lane, then finally moved to the right shoulder and stopped.

As I approached the truck, I noticed the reverse lights were on. I approached the passenger side, defendant was moving around in the truck, looking for something. He reached across to open the window or door, then stopped, then turned the ignition off. He tried to open the window, then turned the key back to the run position and lowered the window. I asked him to put the truck in park, and he looked at me with a confused look. I said, "you're in reverse, please shift the transmission to park". He complied with that request. I noticed a strong sweet odor of an unknown alcoholic beverage coming from his breath when he spoke. I identified myself and told him why I stopped him. I asked him how much he'd had to drink, and he said some, then said 2 or 3 drinks.

Defendant got out of truck at my request, pausing to turn the ignition key on and off again. His face was very flushed (fair skin, appeared to be sun-burned), his eyes were bloodshot and watery. I asked him if he had any injuries or physical defects, and he said he had his spine fused in mid-February. I asked if he could walk and stand and he said he'd try. I asked if he was taking medication or drugs, and he said Adderall for ADD, and that he took it this morning. I had to remind him 4 times not to put his hands in his pockets. FSTs were performed on the shoulder as follows:

HGN: orbital sway, lack of smooth pursuit - both eyes; onset prior to 45 degrees - both eyes; distinct at maximum, both eyes.

W&T: did not maintain stance during instructions (stepped back and to right, raised arms to demonstrate "don't raise arms"), stepped off to right then crossed right over left on step 4, 10 steps, stepped in circle with both feet when turning & stepped off to right.

OLS: right foot, put foot down as soon as he lifted it, otherwise performed.

Nose touch: all attempts, pivoted at elbow and touched 2nd knuckle to tip of nose

Alphabet: sang (monotone), swayed orbital

Rhomberg: I stopped him after 60 seconds, swayed orbital the entire time.

Defendant was arrested for DUI, handcuffed and secured in my car. He was quiet and polite, although he complained that this would ruin his life. He said he had a prior DUI in Massachusetts in 2009. Alltime towing was dispatched by rotation for his vehicle. I transported to the PBSO BAT.

When I arrived at the BAT, I conducted a twenty minute observation of defendant, then escorted him to the test room with DUI tech S. Owen. Defendant agreed to take breath test. During the first sample attempt, he failed to blow a sustained breath, resulting in a low sample volume. I read Miranda and defendant requested a lawyer.

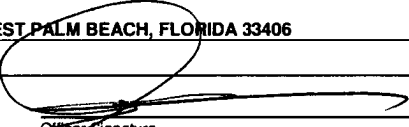

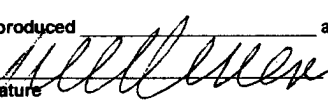

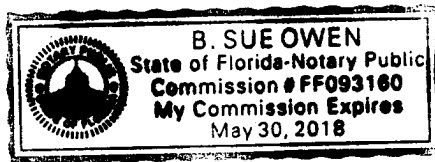
