Andrew provided me with his FL DL and his wife's FL DL. According to Andrew, he and his wife, Valerie Smith, had an argument in their hotel room (room 211) during which she punched him in the face. Smith stated he and his wife are currently homeless and have been placed at the Boca Inn for the past week and a half by a church charity. Smith stated he returned to the hotel from his job at Domino's Pizza in Juno Beach earlier that night and began speaking with his wife. Andrew stated at some point an argument began, during which Valerie punched the left side of his face with a closed fist using her right hand. It should be noted I did not observe any visible injuries on Andrew's face. Andrew stated he did not require medical attention. Initially, Andrew stated Valerie punched him while they were standing in the room by the front door. Later, Andrew stated Valerie punched him while they were standing between the second bed and the bathroom area of the room. Smith stated all of this occurred in front of their 3 children, Atlas Smith-Cosentino, Apollo Smith, and Venus Smith

I then met with Valerie Smith at room 211 of the Boca Inn. According to Valerie, Andrew had been drinking and started an argument with her. Valerie stated she was concerned so she began audio recording the argument with her cell phone. Valerie advised Andrew grabbed her by the wrist and pulled her off of the bed closest to the bathroom. Valerie stated she tried to calm Andrew down while he physically pulled her into the bathroom and began threatening her. Valerie claimed Andrew repeatedly stated she deserved to "have the shit beaten out of her." Valerie stated once Andrew pulled her into the bathroom he continued to yell and curse at her and eventually punched her on her left jaw with his right hand. It should be noted I observed swelling on Valerie's left jaw area. Valerie stated Andrew then pushed her against the wall with his left hand and pressed his right forearm against her neck and applied pressure, which Valerie stated caused her to gasp for air. Valerie then stated she pushed Andrew off of her and attempted to leave the bathroom, at which point Andrew punched her head again at which point Andrew told Valerie "to call the cops" because "you'll be dead either way." Valerie said she then left the room but was followed by Andrew who pushed her onto the bed closest to the bathroom and got on top of her to hold her down. Valerie ran to the front door of the room and opened it to try and call for help from other hotel guests, at which point Andrew ran to her to try and stop her. Valerie repeatedly told Andrew to stop because she knew he was drunk and didn't want him to go to jail. Andrew then left the room, taking several of their important documents, including Valerie's FL DL, their marriage license, and their credit cards. Valerie advised their three children were present during the incident. Valerie stated she did not need medical attention. Valerie then let me enter the hotel room to retrieve her phone so that I could listen to the video recording. The video shows a black screen, but has full audio. On the recording, which was dated 08/08/2017, Andrew can be heard yelling and Valerie, who can be heard attempting to calm Andrew down. Valerie is then heard shrieking as Andrew grabs her and pulls her into the bathroom. Just a few seconds later, Andrew is heard punching Valerie, which makes a loud noise, followed by Valerie yelling in pain. Valerie emailed the video recording to my city email address.

Based on the information obtained during my investigation, Valerie's statements, and the audio recording, I arrested Andrew Smith for domestic battery in violation of F.S.S. 784.03(1), domestic battery by strangulation in violation of F.S.S. 784.041(2). Andrew Smith was taken to BRPD for processing and then turned over to Palm Beach County Jail.

Photographs were taken of Valerie's injuries. Valerie wrote a written victim statement and was then provided with a Domestic and Dating Violence Notice of Legal Right's and Remedies pamphlet with a case number. The video recording, photographs of the injuries, and written victim statement were submitted to BRPD evidence. Given that the children were present, DCF was notified.
