Waychowsky #1198) responded to the lobby of the Tequesta Police Station, reference harassing phone calls and violation of court order. Upon arrival, I met with the victim, Ryan Fitzhugh. Fitzhugh stated his ex-girlfriend, Angela Duncan has a no contact court order against her. She is ordered to have no contact with Fitzhugh and their son. Duncan has a documented heroine addiction, which led to the court order. Fitzhugh showed me court documents stating the no contact order. He then played me voice-mails from Duncan calling on a private/blocked number at approximately 4:00AM that morning. In all there were over 20 calls from the same blocked number during the time voice-mails were left. The voice-mails contained Duncan threatening Fitzhugh to get their son back. Duncan has also been harassing Fitzhugh on social media for weeks. Fitzhugh completed a sworn witness affidavit and has supplied the proper court documents detailing the no contact order. Based on the witness statement and documents provided, I believed probable cause exists to charge Angela Duncan with violation of a court order per F.S.S. 921.244 and harrassing phone calls per F.S.S 354.16.1c. Before me personally appeared the above named law enforcement officer with the TEQUESTA POLICE DEPARTMENT, and who being duly sworn, states the Defendant ANGELA DUNCAN did commit the acts stated in this Probable Cause Affidavit. Based upon this sworn statement of facts, I find probable cause that the defendant did commit the crimes listed in the Charges Section of this affidavit.
