On Friday October 18th, 2019 at approximately 2226 hours I was dispatched to 1441 Brandywine Rd apartment 400H in reference to a delayed battery. Upon arrival units on scene made contact with the victim later identified as Murphy, Allix DOB: 06/25/1991, who stated the following. Murphy advised she got into an argument over text messages with her ex-boyfriend of three years, over him taking the apartments laundry detergent. Murphy advised her ex-boyfriend Barr, Chase white male DOB: 12/28/1986 took the laundry detergent from the home and it upset her, and she wanted it returned immediately. Murphy advised she went into Barr's room and dumped his clothes all over his bedroom floor and took a picture of it and sent it to Barr, while he was gone. Barr arrived home with a white female named Angela possibly 25-30 years of age, wearing a black t-shirt, with black jogging pants and white sneakers. Angela was possibly 5'9 to 5'10 and weighed 115 to 120lbs. Angela has brown hair and her hair was tied up in a bun hair style. Upon Barr and Angela entering the home Murphy spotted Angela armed with a pair of purple brass knuckles on her hand. Murphy asked Barr to come to his room so they could squash the argument between one another while Angela remained out in the living room. Murphy and Barr came to an agreement and ended the feud between themselves. Murphy reminded Barr that their civil agreement to not have guest over was still in play and he agreed and attempted to remove Angela from the apartment. Angela refused and started becoming loud and irate. Angela shouted, "no I'm not leaving now, I'm going to go in her room and mess up her stuff". Angela attempted to enter Murphy's room, but Barr bear hugged her and attempted to pull her out of the apartment. Murphy ran to the living room front door and opened the door so he could pull her out of the home. Barr and Angela made their way to the front door and were just about to exit when Angela reached over Barr while being restrained and

punched Murphy in the side of the head with the purple brass knuckles. Barr at this time rushed Angela outside and secured her in an unknown vehicle and came back to check on Murphy. Murphy informed Barr she was seriously hurt and bleeding from the left side of her head. Barr observed the injury and then fled the scene without saying anything to Murphy. Murphy at this time called Police and stood by on scene until Police arrived. I took a look at Murphy's injury and she had a small laceration to the left side of her head and blood was observed oozing from the cut. WPBFR #6 arrived on scene (Run#19-21748) and advised Murphy needed to be transported and most likely needed stitches for the wound. Officer Campbell assisted on scene with taking pictures of the injury and Officer Anneese assisted with issuing the Marsy's law form. Murphy chose to invoke her rights. Murphy was transported to JFK North Hospital for further medical treatment by WPBFR 6. I arrived at the hospital to conduct a sworn tapped statement with Murphy. Murphy advised she could id the suspect Angela but was unable to provide a full name or residence at this time. Murphy advised she does wish to prosecute and does not have a personal relationship with Angela, she has only seen her once before. Murphy advised during the sworn statement the purple brass knuckles she was struck with belonged to Barr, and she has seen them before several times. Murphy advised she would contact Police if she received anymore information on Angela. I issued Murphy a case number and advised her to contact Police immediately if she see's Angel again over her home and to stay away. I attempted to contact Barr to obtain an Id on Angela or contact number, but no one answered the phone. Based on the above case facts there is no probable cause at this time due to no positive ID of the suspect. This case will be forwarded CID for further review. BWC was activated and no witnesses or suspects could be located. All photos taken on scene were uploaded to evidence.com. On Saturday October 19th, 2019 at approximately 2004 hours I was dispatched to 1441 Brandywine Rd Apt 400H in reference to a case follow up under case #19-17927. I arrived on scene and made contact with the victim white female Murphy, Allix DOB: 06/25/1991. Murphy advised she would contact Police at a later date and would gather the suspects information to obtain the positive ID. On October 19th, 2019 I received an email to my West Palm Beach Police city email account from the victim Murphy. The email listed the possible suspect Angela Curry white female DOB: 06/04/1992 and had multiple pictures of Curry which were all provided by Murphy. I conducted a palms personal check on the suspects information provided by the victim Murphy, and it was a match on the suspects

Please refer to her supplement report for more details. Murphy immediately pointed to photo number five without any hesitation and successfully picked the suspect out of the photo lineup. Murphy advised the suspect she picked on the photo lineup is the women who assaulted her with the purple brass knuckles. Murphy due to the injury she sustained from Curry received two staples to the side of her head, to aid in closing her laceration. Based on the positive identification from the photo line up and the injuries caused to the victim by the suspect Curry, Angela I have probable cause to charge the defendant with F.S.S. 784.045 Aggravated Battery.
