On Thursday, December 26, 2019 at approximately 2308 hours, I was dispatched to the Main Entrance of Breakers Hotel (1 South County, Palm Beach) for a drunk and disorderly female who was identified as Laskawska, Angelika Dorota, W/F, DOB 06/05/91. Sgt. Badolati was working a security detail at the Breakers and had requested our response.

Upon arrival at the Main Entrance door, we observed Laskawska yelling and swearing at Breakers employees and Sgt. Badolati as she was being escorted from the premises. According to witnesses, Laskawska was initially inside the HMF area of the Breakers when she was involved in a verbal argument with persons at the bar and creating a disturbance. Laskawska was observed by hotel security hitting her boyfriend (Ben Peress W/M DOB 01/05/90) at the bar and was immediately asked to leave. Peress declined to prosecute and completed a PBPD Witness Statement Form. Peress stated Laskawska "grabbed my throat and pushed my head back." Laskawska was told numerous times from Breakers Security and Sqt. Badolati to leave the bar and she refused to do so. Breakers security wanted her trespassed from the hotel and Laskawska refused to identify herself to Sgt. Badolati, and told him to "Go fuck yourself." She continued to become belligerent and she had to be handcuffed and escorted off the property. While in handcuffs Laskawska continued to shout profanities at myself and other officers on scene and continued to disrupt hotel guests.

Due to the fact that Laskawska was warned by Sgt. Badolati to leave the premises multiple times, Laskawska refused to leave and committed the offense of Trespass. Due to the fact, Laskawska continued to be disruptive to other guests at the Hotel by yelling and cussing while in the Hotel Bar. Laskawska affected the peace and quiet of persons who may witness her behavior and by engaging in such conduct as to constitute a breach of the peace and the offense of Disorderly Conduct.
